# Hangar and Tiedown Waitlist Application

## Waitlist Application Process

Thank you for your interest in applying for a hangar and/or tiedown spot at Boeing Field. We currently have a waitlist for all leased spots located on the airfield. Please see the below information regarding what to expect during the application process.

### Tiedowns:

#### **Additional Information Regarding Tiedowns at BFI:**

- The waitlist is currently anticipated at 1-3 years depending on turnover and availability.
- There is no fee associated with being placed on this list.
- Once awarded, the current tiedown monthly rental cost is as follows:
  - o \$124.12 total cost, including the Washington State Leaseholder Excise Tax at 12.84%

To begin the application process, click on the DocuSign Link: [Tiedown Waitlist Application](#)

- Fill out the information for a tiedown, including your name, contact information, and any additional information that will assist Airport Operations in placing you on the waitlist.
- If you do not have an aircraft at the time of applying, please fill out the aircraft type as UNK. Please note that when you are awarded a spot, you will have 90 days to purchase an aircraft.
- Finish signing and submit to Operations

### Hangars:

#### **Additional Information Regarding Hangars at BFI:**

- 2-5 year waitlist depending on turnover and availability.
- One application will need to be completed per hangar
- There is a \$110.00 fee associated with being placed on this list. This fee is applicable to each hangar type that is applied for.
- Once awarded, the current rental rate of the hangar will also include the Washington State Leaseholder

Excise Tax at 12.84%

To begin the application process, click on the DocuSign Link: [Hangar Waitlist Application](#)

- Fill out the information for a hangar, including your name, contact information, and any additional information that will assist Airport Operations in placing you on the waitlist.
  - If you do not have an aircraft at the time of applying, please fill out the aircraft type as UNK. Please note that when you are awarded a hangar, you will have 90 days to purchase an aircraft.
  - Finish signing and submit to Operations
- Please remember that you will need to fill out a separate application for each type hangar you wish to apply for and a waitlist application fee will need to be submitted for each waitlist.
    - For example: If you are interested in applying for a small T Hangar and a large T Hangar, you will need to complete two separate applications with two separate deposits.

## **Next Steps:**

Once completed, the application(s) will then be sent to Airport Operations and Airport Finance where your information will be placed on the applicable waitlist. Please allow up to 14 business days for your application(s) to be processed. Once you have been assigned a waitlist number, Airport Operations will finish updating the DocuSign form, and you will receive a copy with your waitlist number attached.
