  - Overall, the Tyee HS project had an Apprentice Utilization Rate of 19.96 percent with \$6,391,850 in wages paid to Priority Hire workers.
- Seattle PS
  - The Seattle PS CWA (SCWA) applied to 5 school projects. Jessica provided an update on their SCWA requirements and goal attainment for each project. 3 SPS pre-apprentice graduates worked on these projects, and one of the graduates has also been hired to work on the Memorial Stadium project, which broke ground in July.
