Executive Summary

Purpose, Scope and Approach	• PFM Asset Management, a division of U.S. Bancorp Asset Management (“PFMAM”) prepared this report to update our ongoing analysis and to address any Investment Pool developments since our March 2026 review. Our approach included a detailed portfolio analysis and Investment Policy review, based on the County’s Investment Policy, dated July 26, 2017. • Our analysis was based on the Investment Pool’s holdings as of June 30, 2026, with reference to holdings in past periods. • The review encompasses all current investments in the County’s Investment Pool.
Investment Program and Portfolio Review	• PFMAM reviewed the County’s portfolio with respect to Investment Policy Compliance, Sector Allocation, Issuer Concentration, Credit Quality, Maturity Distribution, and Duration Distribution. • The County’s Investment Pool appears to provide ample liquidity, is well diversified, and is of sound credit quality. All holdings are investment grade and pose very low risk to principal.
Market Recap	• U.S. growth remains resilient as AI-driven investment offsets a moderating consumer • Headline inflation may be at or near its peak as the energy shock fades, though flare-ups in the Middle East conflict and potential delayed passthroughs to core inflation remain key risks • The labor market is in balance, though real wage growth remains modest • AI investment continues to drive growth while fueling inflation in tech-related categories • The Federal Reserve (Fed) left policy rates unchanged at 3.50-3.75% • New Fed Chair Kevin Warsh stressed restoring price stability • Forward guidance was removed to refocus markets on economic fundamentals and incoming data rather than the Fed’s policy response • Nine participants projected a 2026 rate hike though Warsh did not submit projections • Treasury yields moved higher on a more hawkish Fed • Given current pricing of Fed rate hikes, we continue to find value in the front end • Longer-term rates face two-sided risks from inflation and growth dynamics • Credit spreads remain tight as resilient growth, stable labor conditions, and strong demand outweigh valuation concerns
Observations	• The portfolio is of very high credit quality. The majority of securities (approximately 78%) are explicitly guaranteed or carry a high level of support by the U.S. Government (U.S. Treasury, Federal Agency and U.S. instrumentalities) and/or possess overnight liquidity (Washington State LGIP, bank deposits, and repurchase agreements). • The County maintained broad issuer diversification during the quarter. • The Portfolio’s duration decreased over the quarter and stands at 99% of the benchmark’s duration.

Additional Notes to the Investment Policy

- The Pool will maintain an effective duration of 1.5 years or less.
- The Pool will maintain at least 40% of its total value in securities having a remaining maturity of 12 months or less.
- Floating rate and variable rate securities are permitted subject to the following criteria:
 - 1) The rate on the FRN/VRN resets no less frequently than quarterly; and
 - 2) The FRN/VRN is indexed to a money market rate.
- Major NRSRO is defined as Moody's and Standard & Poor's.
- Purchases prior to 9/15/16 are considered grandfathered in for issuer limit purposes and can be held to maturity.

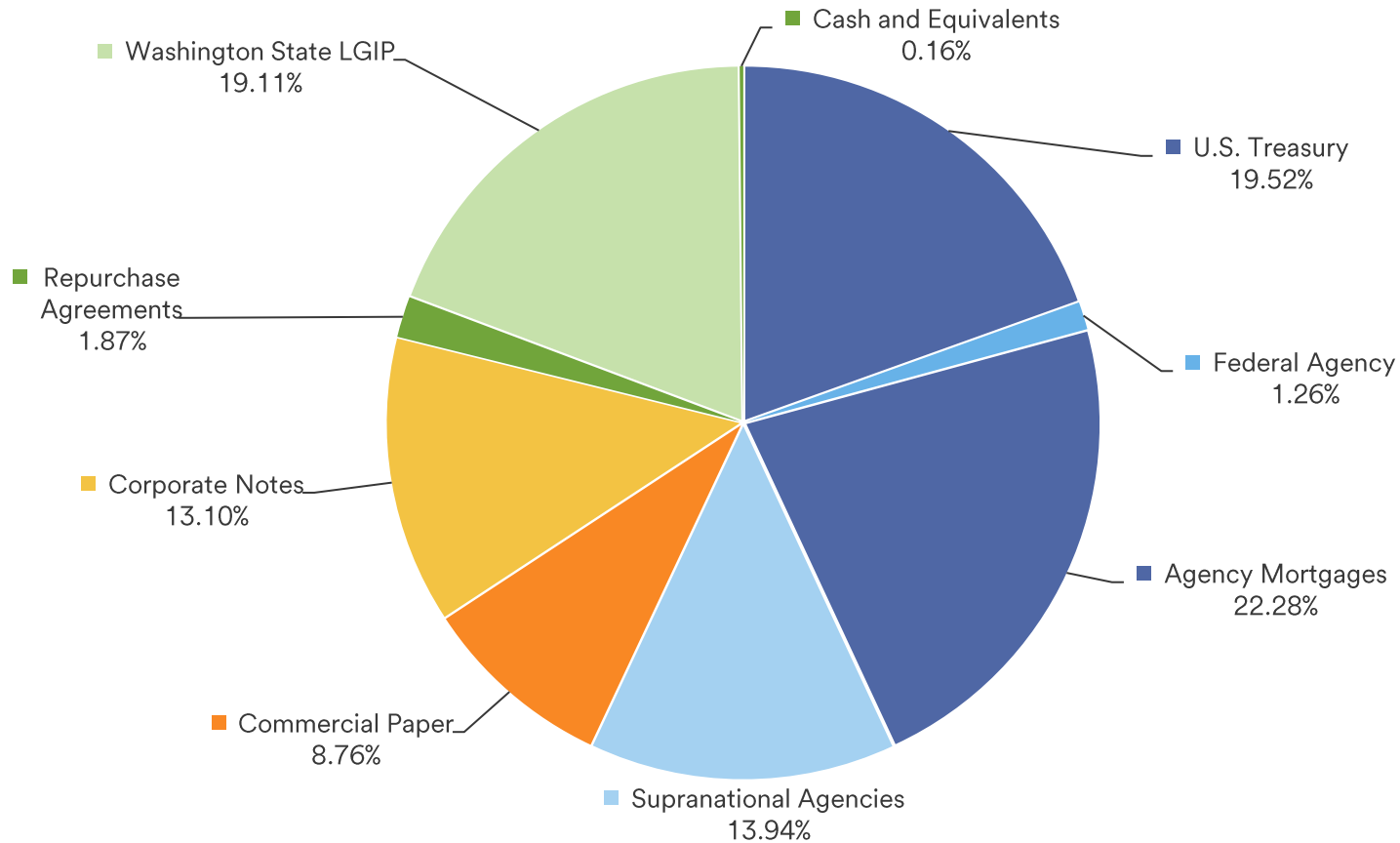
Topic	Observations
Sector Allocation	- All sector allocations fall within the limits set forth by the County's Investment Policy Statement. The Pool is predominantly invested in U.S. government securities which are either explicitly guaranteed or carry a high level of support by the U.S. government. - The County's Investment Pool balance (market value) as of June 30, 2026, was \$10.7 billion, a \$1.1 billion increase from last quarter. - The County's Investment Pool decreased allocation to Supranational Agencies (-4.96%), Agency Mortgages (-2.55%), Corporate Bank Notes (-1.24%), Commercial Paper (-0.76%), Federal Agency (-0.43%), and Cash and Equivalents (-0.06%). - The County's Investment Pool increased allocations to the Washington State LGIP (+4.76%), U.S. Treasury (+3.57%), and Repurchase Agreement (+1.66%). - All sectors remain within applicable policy limits.
Credit Quality	- Approximately 57% of the County pool's assets are directly guaranteed or supported by the U.S. government and roughly 13% of the assets are indirectly guaranteed via a portion of the state LGIP allocation and its underlying investments. - Combined corporate allocations (both commercial paper and corporate notes) decreased to 21.9% of the portfolio from 23.9% last quarter, and all securities remain investment grade. Combined allocations to corporate notes and commercial paper continue to be below the maximum allocation limit of 25%. - Total allocations to corporate related issues also do not exceed the 50% allocation limit set forth in the County's Investment Policy.
Maturity Distribution	- All maturities fall within the limits set forth in the County's Investment Policy. - Approximately 50% of the Pool's assets mature in one year or less, above the minimum of 40% that is mandated by the Investment Policy.

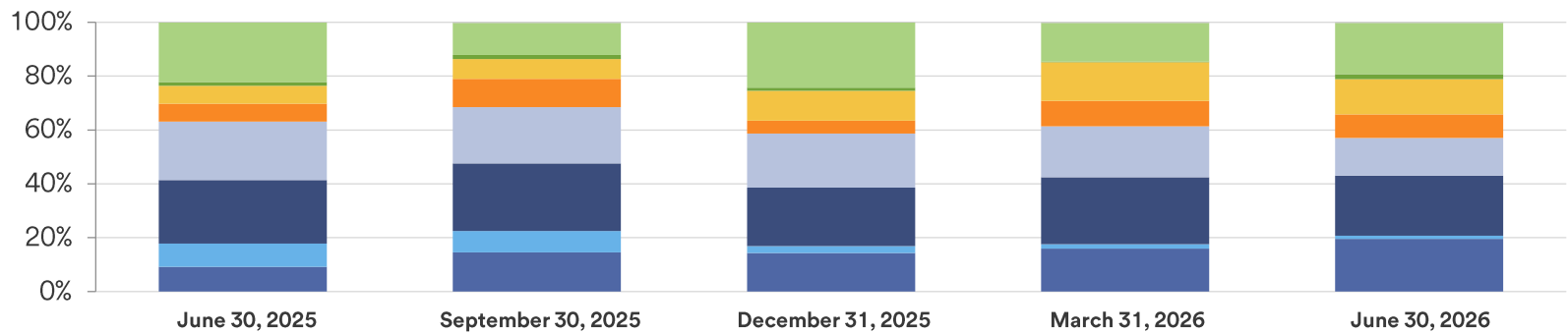
Sector Diversification

Changes in Sector Allocation

- Over the past 12 months, the portfolio has increased exposure to U.S. Treasury (+10.39%), Corporate Bank Notes (+6.39%), Commercial Paper (+2.19%), Repurchase Agreement (+0.53%), and Cash and Equivalents (+0.04%) while decreasing exposure to Supranational Agency (-7.81%), Federal Agency (-7.38%), the Washington State LGIP (-2.99%), and Agency Mortgages (-1.36%).
- During the second quarter:**
 - U.S. Treasuries** Exposure to U.S. Treasuries increased +3.57% from 15.95% to 19.52%.
 - Federal Agencies** The allocation to agencies, excluding supranationals and mortgage securities, decreased by -0.43% over the quarter.
 - Agency Mortgages** Allocation to agency mortgages decreased by -2.55%, ending the second quarter at 22.28%.
 - Supranational Agencies** Allocation to supranationals decreased by -4.96% over the period.
 - Commercial Paper** Commercial paper allocation decreased by -0.76%.
 - Corporate Notes** The allocation to corporate notes decreased over the quarter to 13.10%.
 - Repurchase Agreements** The portfolio's allocation to repurchase agreements increased +1.66% from 0.21% to 1.87% of the portfolio.
 - Washington State LGIP** The State LGIP increased by +4.76% from 14.34% to 19.11% of the portfolio over the quarter.

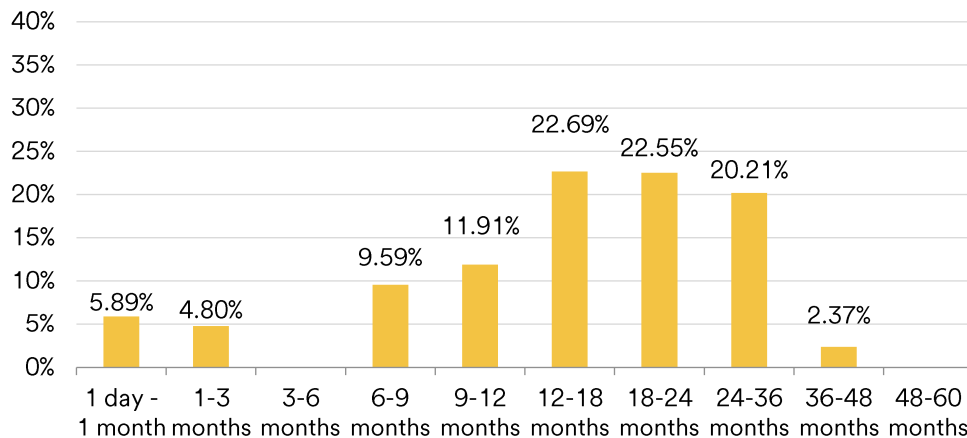

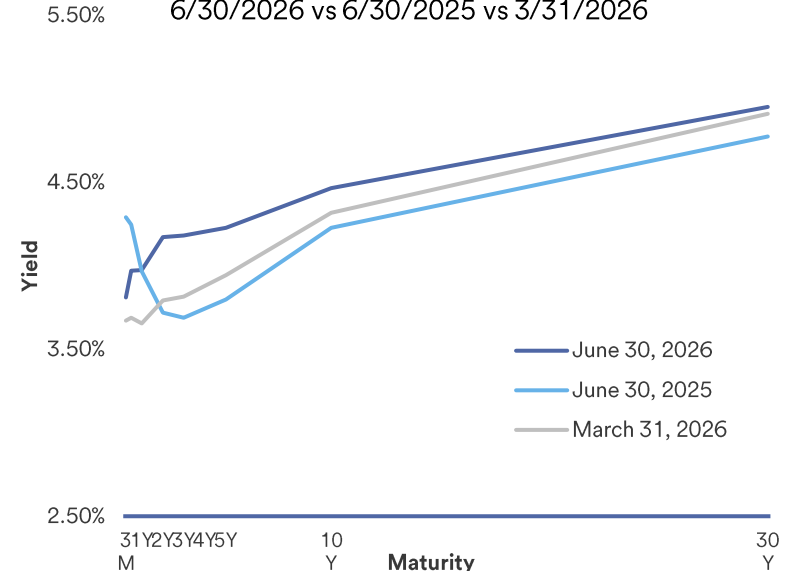
II. Sector Allocation – U.S. Treasury Securities

Topic	Observations
Observations	- The County's balances held in U.S. Treasuries increased from 15.95% of the total portfolio to 19.52%. - The U.S. Treasury yield curve continued to flatten over the quarter, with a notable sell-off in the front end. The 2-year yield surpassed 4% for the first time in over one year, which is a key technical threshold. - Approximately 32% of all Treasury holdings have remaining maturities of one year or less. - The weighted average maturity (WAM) of the County's Treasury allocation decreased over the quarter from 578 days to 524 days as a result of new purchases in the 6-9 month maturity range and allowing longer dated securities to roll down the maturity range. - The chart on the left below displays the current maturity distribution of the County's allocations to U.S. Treasuries while the chart on the right compares the current shape of the Treasury yield curve to the curve last quarter, and the yield curve one year ago. - The County's Treasury holdings are laddered out along the yield curve, favoring the 12-18 month and 18-24-month portions of the yield curve.

as of June 30, 2026



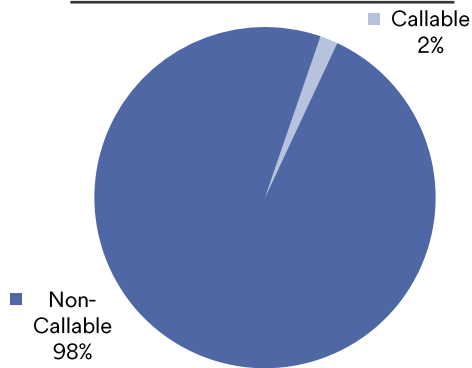
U.S. Treasury Yield Curve
6/30/2026 vs 6/30/2025 vs 3/31/2026



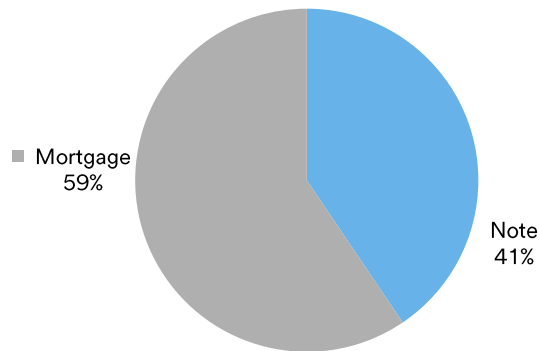

• The County’s federal agency holdings continue to be well diversified by issuer. All issuer allocations fall within the issuer guidelines and security structures in the County’s Investment Policy (max per agency issuer 35%).				
• The percentage of the portfolio invested in federal agencies, excluding supranationals and mortgage securities, decreased by -0.43% in the quarter from 1.69% to 1.26%. The portion of callable federal agency securities increased to 1.7% this quarter.				
• All supranational agency holdings are below the 35% issuer limit and represent approximately 13.9% of the entire portfolio.				
• The County Pool's allocation to agency mortgages is approximately 22.3% of the total portfolio.				

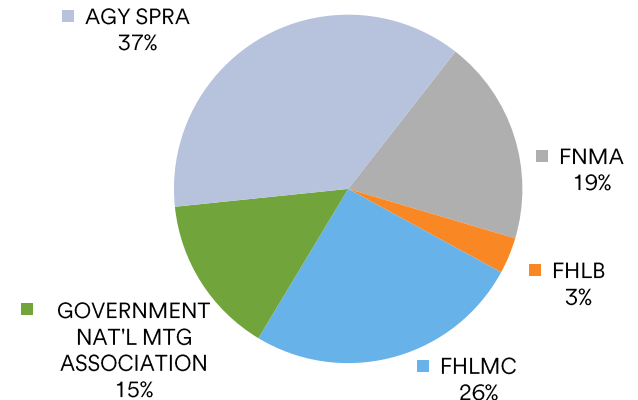
Callable vs. Non-Callable

As of June 30, 2026

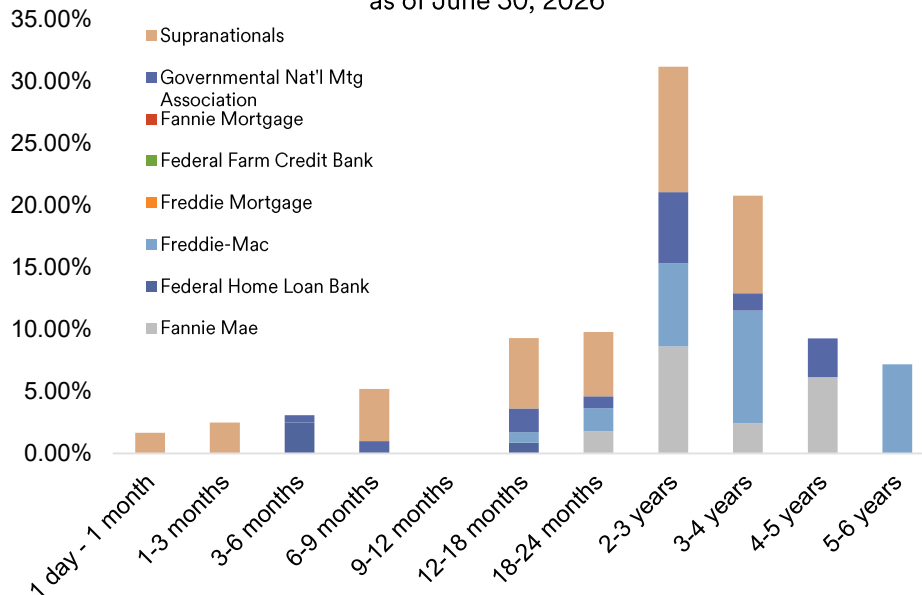

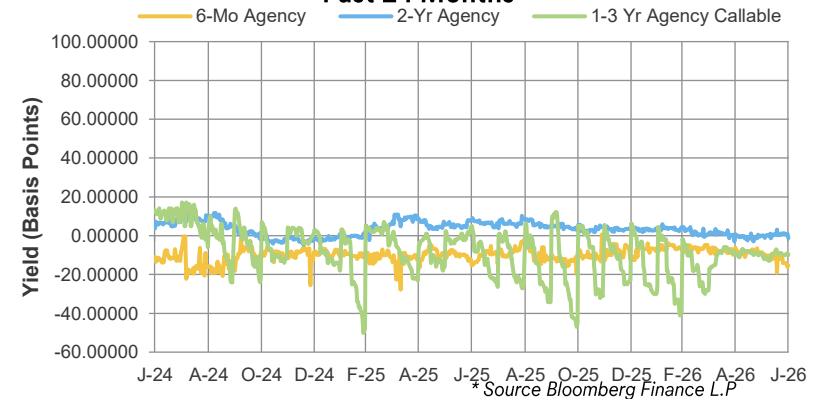
II. Sector Allocation – Federal Agencies

Topic	Observations
Maturity Distribution	- The County's federal agency maturity distribution falls within the limits set forth by the Investment Policy Statement. - Over the quarter, the weighted average maturity (WAM) of the County's federal agency holdings, including supranationals, increased from 726 days on March 31 to 923 days as of June 30. - The portfolio decreased its allocation to both federal agencies and supranational agencies. - Federal Agency issuance remained limited, keeping spreads narrow and excess returns muted. Market concerns around privatization have abated for the time being.

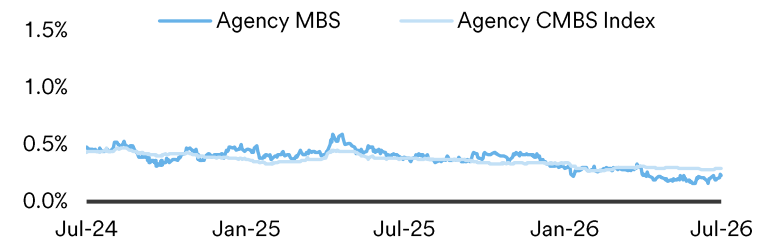
Federal Agency Maturity Distribution by Name

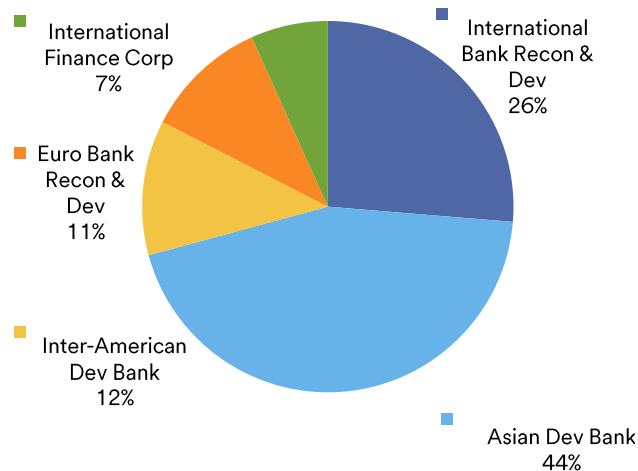

II. Sector Allocation – Supranational Agencies

Topic	Observations
Credit Distribution	- Based on the holdings as of June 30, 2026, zero supranational security matured through the first quarter. - The County maintained its exposure to five supranational issuers and decreased allocation to the sector by 4.96%. - Supranational issuance remained limited, keeping spreads narrow and excess returns muted. - The portfolio's allocation to supranational agencies is relatively balanced across maturities. However, allocation to supranationals with maturities greater than 1 year increased over the quarter from 64.5% to 77.5%.
Spread to Agency Rates	- The chart on the right shows the spread between supranational agencies and federal agency securities. - Supranational spreads remained low throughout Q2. Issuance and returns remained light.

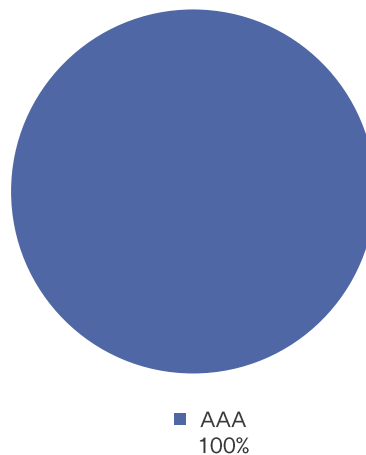
Issuer Distribution

As of June 30, 2026

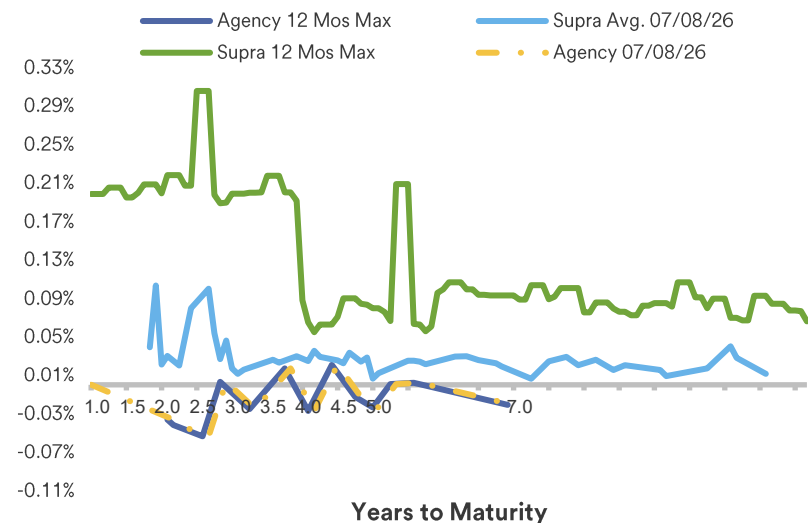


Credit Distribution

As of June 30, 2026



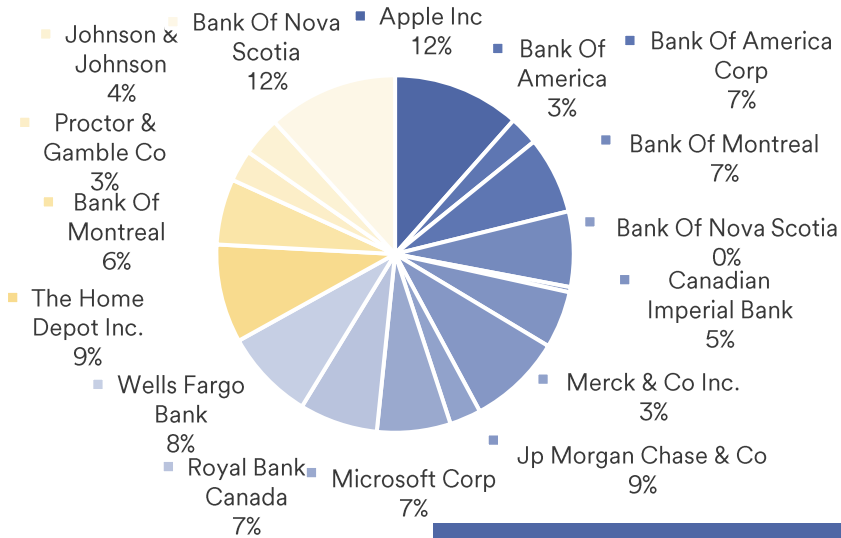
Supranational Agency vs. Federal Agency Yield Spreads

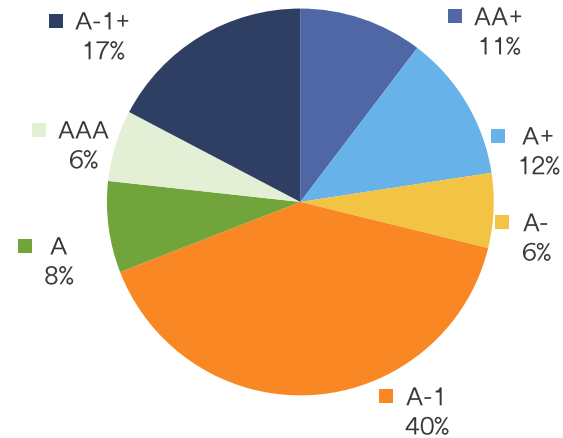

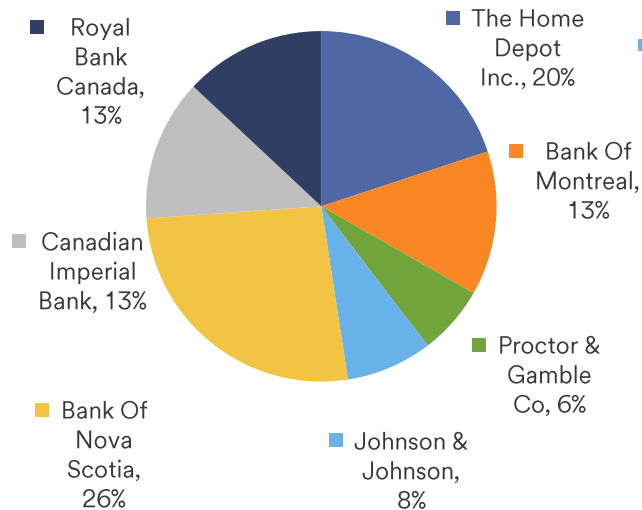

II. Sector Allocation – Commercial Paper

Topic	Observations
Issuer Diversification	- The County's allocation to commercial paper decreased by 0.76% over the quarter, ending the period at 8.76% of the total portfolio. - The portfolio holds commercial paper from Johnson & Johnson, Proctor & Gamble Co, The Home Depot Inc., Canadian Imperial Bank, Bank of Nova Scotia, Bank of Montreal, and Royal Bank of Canada
Credit Distribution	The overall credit quality of commercial paper in the portfolio has stayed the same over the second quarter.
Conclusions	Short-term credit (commercial paper and negotiable bank CDs) yield spreads remained attractive through the quarter, with additional opportunities emerging across the money market credit curve into quarter-end. Floating-rate notes also saw notable spread widening, ending the quarter 10-15 bps wider.

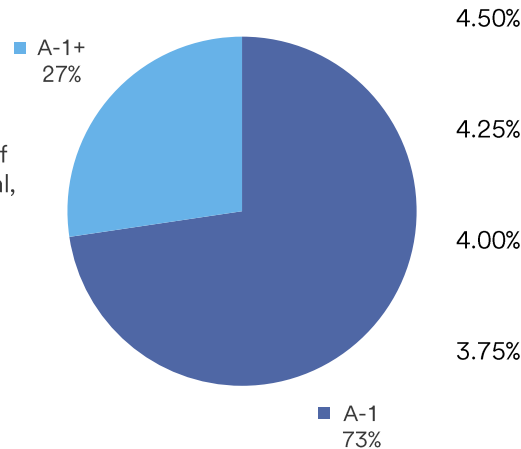
Issuer Distribution

As of June 30, 2026



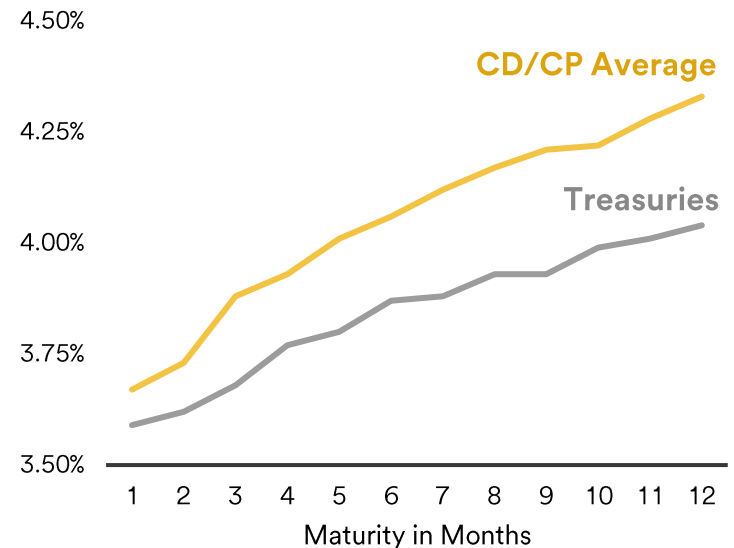
Credit Distribution

as of June 30, 2026

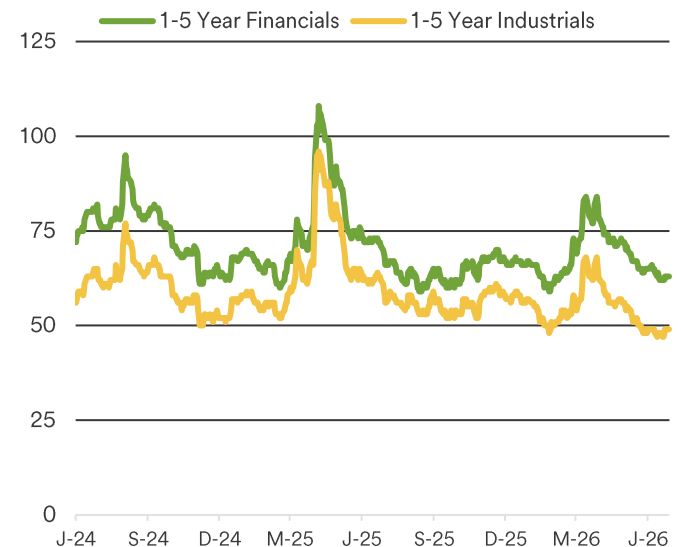


II. Sector Allocation – Corporate Notes

Topic	Observations
Maturity Distribution	- The County's allocation to corporate notes decreased from 14.34% to 13.10% of the portfolio. To end the period, the Pool's corporate note holdings were from high quality issuers, with 100% of its corporate notes carrying a rating of A- or better by S&P Global Ratings. - Callable corporate notes made up 72.91% of the County's corporate sleeve, with most call dates being 1-3 months before maturity. - The weighted average maturity of the corporate note portion of the portfolio is 0.82 years. - The graph on the right below shows the spread for financial corporates and industrial corporates when compared to similar-maturity Treasuries. - Investment-grade (IG) corporate bonds benefited from strong investor demand and generally healthy corporate fundamentals. Credit spreads returned toward historically rich valuations, supporting excess returns during the quarter.

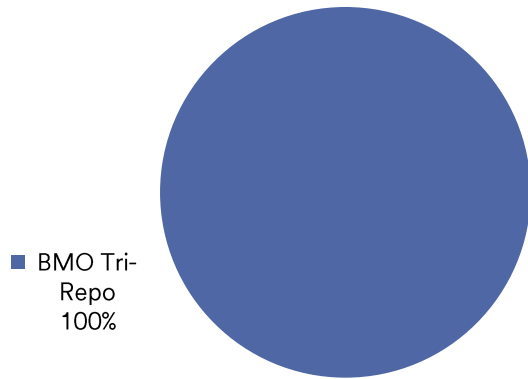
Corporate/Treasury Yield Spreads
June 2024 through June 2026 (in basis points)



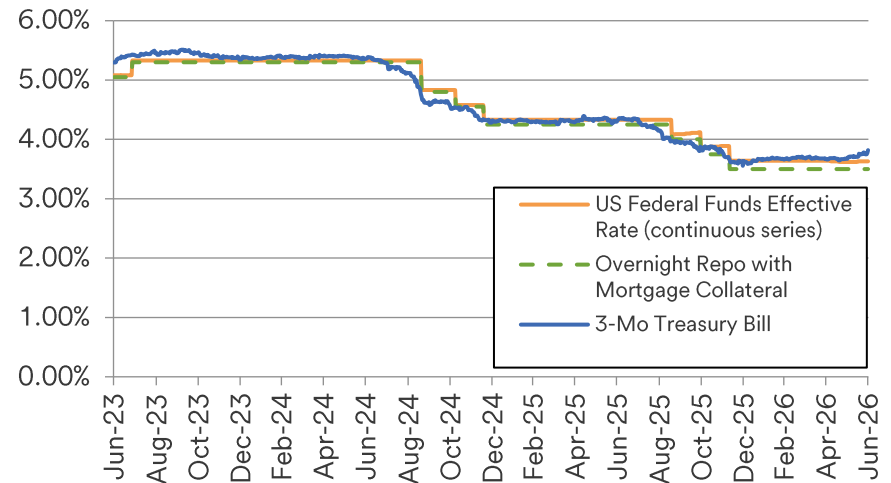
II. Sector Allocation – Repurchase Agreements

Topic	Observations
Issuer Diversification	- The County increased its tri-party repurchase agreement allocation over the quarter by 1.66%. This sector now holds 1.87% allocation in the portfolio compared to the 0.21% allocation at the end of the first quarter of 2026. - At the end of the quarter, the portfolio utilized one repurchase agreement provider, BMO Capital Markets, with an amount of \$200 million. - The allocation falls within the permitted investment guidelines of 25% per issuer and 100% maximum to the sector.
Credit Distribution	- S&P Global Ratings rates BMO's short-term issuer credit as A-1. - While this issuer has a high-quality rating from S&P Global Ratings, the ultimate quality of the repurchase agreement depends on the underlying collateral.
Conclusions	The market sees all-in yields remaining attractive on the short end of the curve, particularly given the split opinions of Fed expectations. Floating rate credit remains an attractive sector for both incremental yields carry and as a hedge against multiple rate hikes this year.

As of June 30, 2026



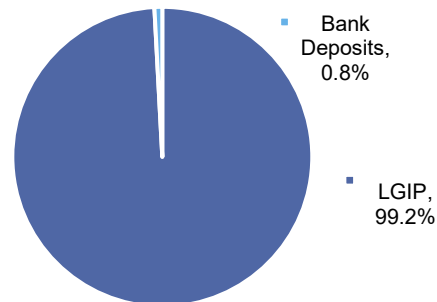
Short-Term Yields
June 2023 through June 2026



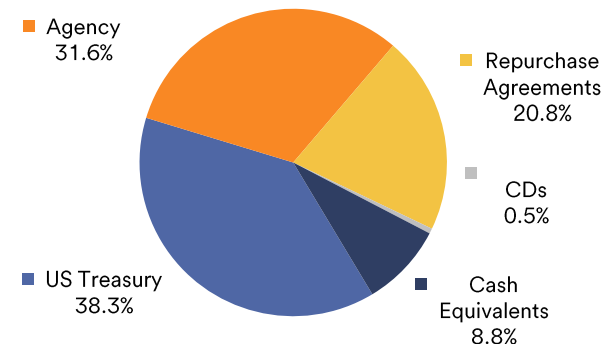

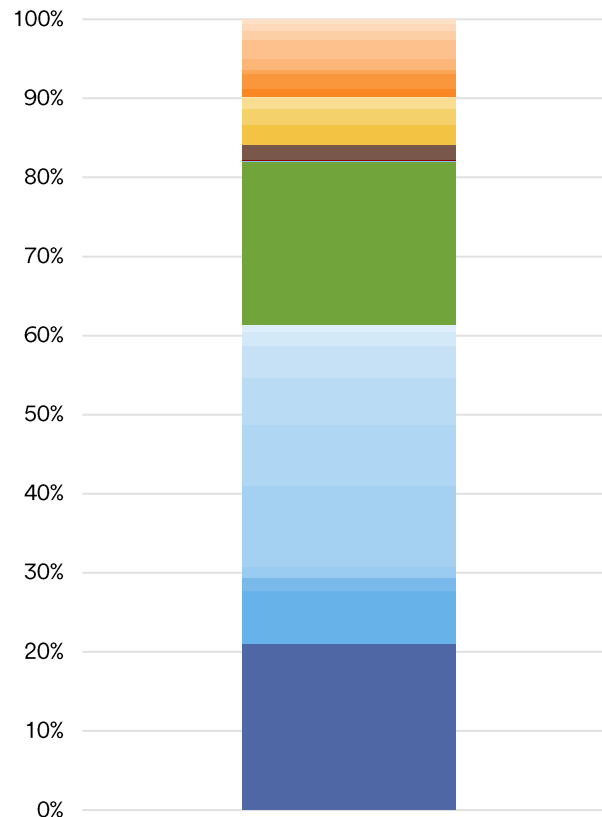

III. Issuer Concentration

Issuer Exposure

- The County maintains a well-diversified portfolio by issuer, as shown in the tables and graph below.
- Approximately 57% of the portfolio is allocated directly to U.S. government guaranteed or government supported entities.
- Of the remaining 43% of the portfolio, about 21% is allocated to very short-term or overnight investment vehicles, including the State LGIP, repurchase agreements, and bank deposits. The remaining 22% is allocated to credit issuers, including commercial paper and corporate notes.

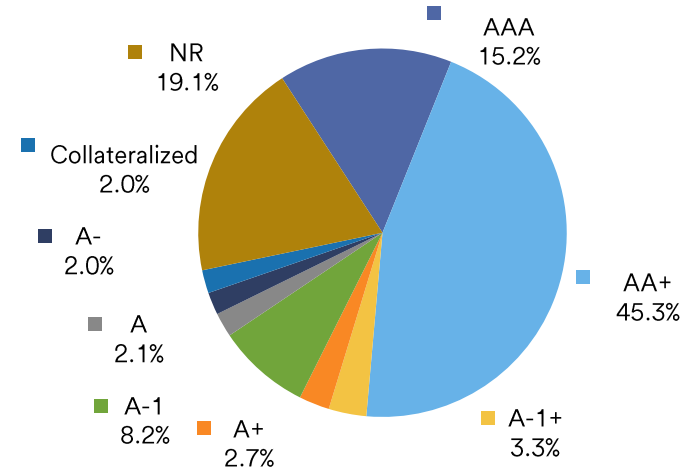
IV. Overall Credit Quality

County Investment Pool Credit Analysis

- The County Pool's overall average credit position remains very strong and is primarily concentrated in U.S. government guaranteed and/or supported securities which maintain a long-term credit rating of AA+ by S&P Global Ratings.
- The County also continued to hold supranational agencies, which are rated AAA.
- The County decreased its credit exposure (commercial paper and corporate notes) with allocations to credit ending at 21.86% of the portfolio, compared to 23.86% last quarter.
 - Commercial paper accounts for 8.76% of the entire portfolio, while corporate notes account for 13.1%.
- Corporate note allocations held throughout the quarter have ratings of A- or higher.
 - Commercial paper allocations are all rated A-1/P-1 or higher.
- The 19.11% NR allocation represents the County's investment in the Washington State LGIP, which is not currently rated by any ratings agency.
- The County's investment in the Washington LGIP includes indirect corporate exposure:
 - Through the LGIP, 4.08% of the County's Pool is allocated indirectly to corporate securities (repurchase agreements and certificates of deposit).

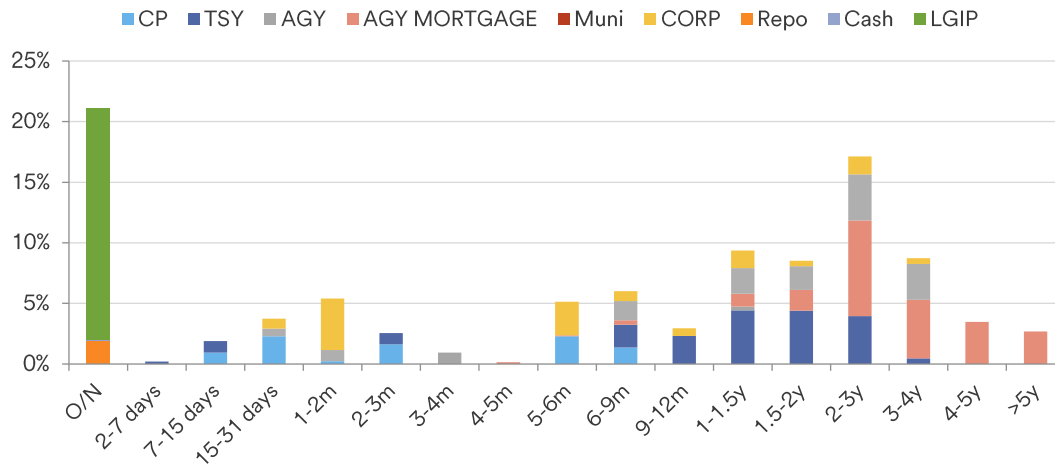

Weighted Average Maturity ("WAM")	- The County continues to invest across its permitted maturity range, as seen in the chart below. - About 50% of the portfolio holdings are scheduled to mature within the next twelve months, well above the 40% mandated by the investment policy. - It appears the County's maturity strategy over the past quarter included: - Targeting the following spaces: - Decreasing short term investments vehicles and going out longer on the curve. - Targeting 4+ years for Agency mortgages - Purchasing longer dated Treasuries than last quarter - The WAM of the portfolio ended the quarter at 496 days, slightly longer than the 467 days WAM from the previous quarter.
Liquidity	The County has increased allocations in the portfolio to the combination of the Washington State LGIP, bank deposits, and repurchase agreements (overnight liquidity), from 15% in the previous quarter to 21% this quarter. Another 6% of the portfolio's holdings are scheduled to mature within the next thirty-one days.

Maturity Distribution as of June 30, 2026



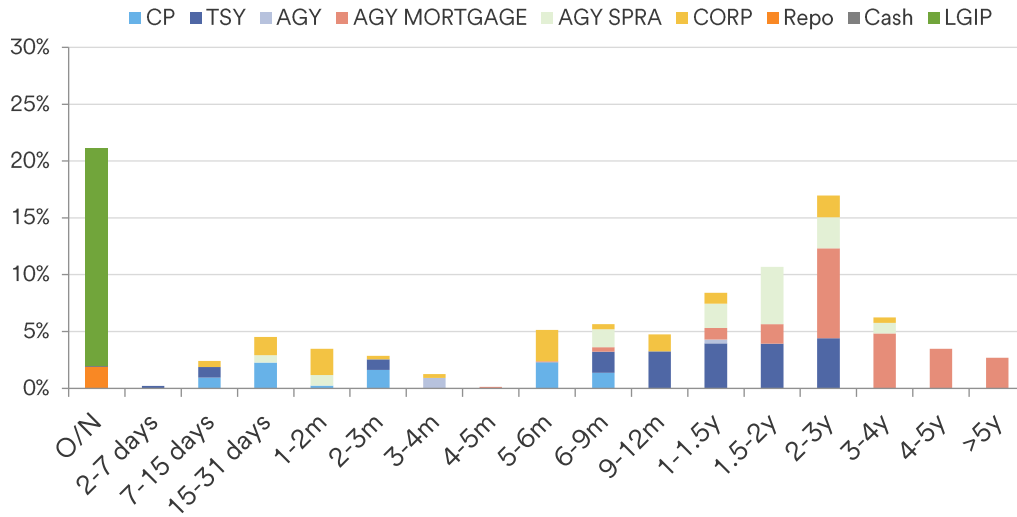

The value of a portfolio with a higher duration is more sensitive to interest rate increases and decreases. - Duration is often quoted in years and is commonly used as a measure of the market risk of a security or portfolio. Duration	- The portfolio's weighted average duration is within the IPS guidelines (no greater than 1.5 years). - As of June 30, the duration of the County Investment Pool was 1.17 years, a decrease from the previous quarter which ended at 1.23 years. - The portfolio is measured against a blended benchmark consisting of 40% ICE Bank of America 3-Month Treasury Index and 60% ICE Bank of America 1-3 Year Treasury & Agency Index. - The overall benchmark duration decreased to 1.18 years this quarter, compared to 1.19 years last quarter. The portfolio's duration decreased from 104% to 99% of the benchmark duration for the period ending June 30.

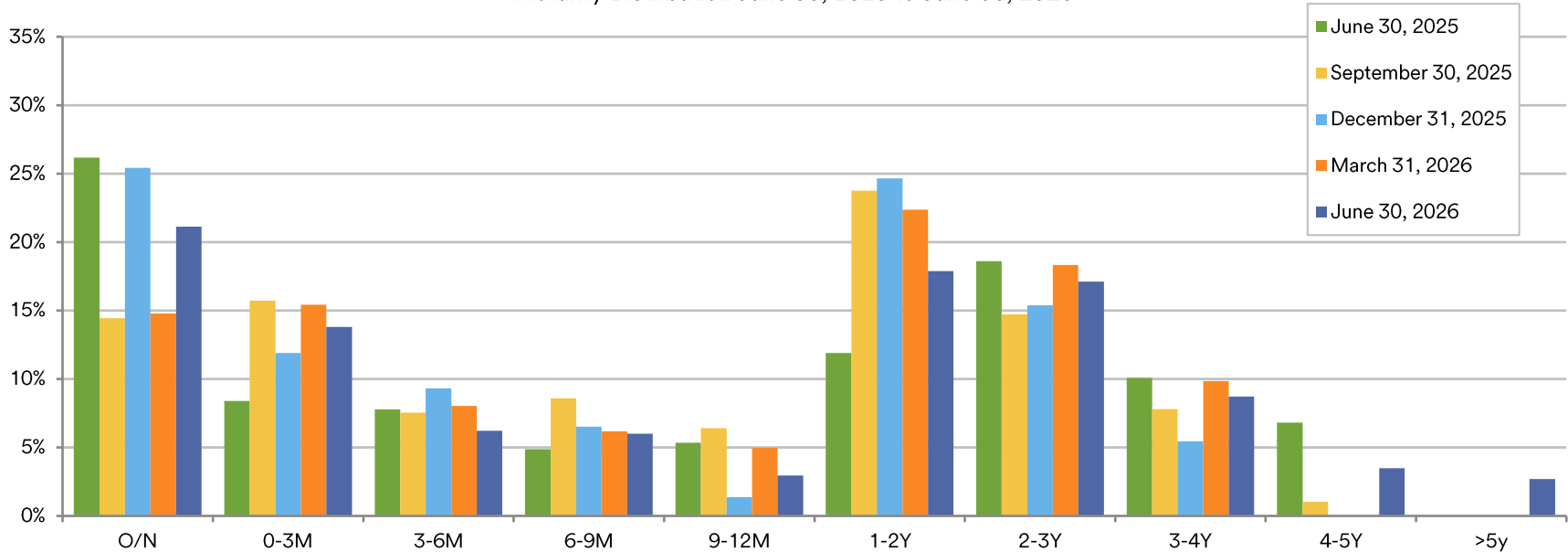

V. Changes in Portfolio Maturity Distribution

Changes in Portfolio Maturity Distribution

- When viewing the current maturity distribution (dark blue bars) in relation to previous periods, a few primary observations are noted:
 - It appears the County has targeted investments in the Overnight, 4-5 year, and >5 year bucket due to slowdowns in prepayments due to rising interest rates.
 - The portfolio is well diversified across maturity buckets under 1 year.
- U.S. Treasury yields increased over the quarter as investors repriced their Fed policy outlook driven by geopolitical turmoil and renewed inflation concerns. Yield increases were led higher by the 2-year maturity reflecting market repricing of Fed interest rate policy over the next several quarters.
- The 3-month U.S. Treasury ended the quarter at 3.82%, 15 bps higher. The 2-, 5- and 10-year U.S. Treasuries ended the quarter at 4.18%, 4.23%, and 4.47%, representing increases of +39 bps, +29 bps, and +15 bps, respectively. Longer duration bond indices experienced the greatest pressure from rising yields, with higher rates adversely impacting valuations.
