This grant includes funding for multifamily affordable housing building decarbonization through direct retrofits, benchmarking, and technical assistance.

About the Program – Multifamily


A program to decarbonize multifamily affordable housing

Full building decarbonization	Naturally occurring affordable housing (NOAH)	50 buildings
Benchmarking services	Unsubsidized and subsidized housing	130 buildings
Technical assistance	Unsubsidized and subsidized housing	25 buildings
Heat pump water heater (HPWH) rebates	Unsubsidized and subsidized housing	300 Rebates

Opportunity - Scope of Work

NOAH Program Administrator

Develop program process flows: Verifications, Sequencing, Tenant Services, and Evaluation

Manage team of subcontractors

Evaluate building systems for decarbonization

Schedule and manage building retrofits

Educate owners and tenants on new systems

Host workforce trainees for direct install projects

Benchmarking Contractor

Set up ENERGY STAR Portfolio Manager (ESPM) accounts

Benchmark 130 buildings

Educate building owner/operator

Monitor ESPM accounts for 6 months

Compliance assistance for buildings over 20k square feet

Technical Assistance Contractor

Full building audit

Decarbonization priority plan

Assistance with external financing options

Full decarbonization of 25 buildings

Eligibility and Application

Who can apply?

- Primary Applicant: eligible entities include non-profit and for-profit firms.
- Subcontractors must have a valid contractor license & applicable local licenses
- Government entities are not eligible to apply
- Subject to prevailing wage requirements & Davis Bacon Act wage requirements

How do I submit my application?

- Applicants will use the JotForm application link to submit all materials
- The submission should include all required materials outlined in sections 1.13A – 1.13H in the Request for Applications

What do I need to submit?

Direct Entry into JotForm

• Firm Information (Section 1.13A – C)

Required Uploads to JotForm

- Application Narrative (Section 1.13D)
- Attachment A: MWBE Utilization Plan (Section 1.13E)
- Attachment B: Cost Proposal (Section 1.13F)
- Attachment C: References (Section 1.13G)

Optional Uploads

• Exhibit 1: Contract Agreement (Section 1.13H)

Application Narrative


Fifteen (15) page maximum to share the following:

Experience, Background, and Qualifications

- Provide team members and qualifications
- Share experience working on similar projects within target communities

Methodology & Approach to the Scope of Work

- Share your strategy for completing the scope of work based on selected service areas
- Discuss where your selected service areas provide synergies and enhance the work product

FAQs

Do I have to apply to all three service areas?

• No. Applicants may apply for any combination of the three service areas. The Applicant must complete all pieces of the service area they apply for.

Are there benefits to applying for one or multiple service areas?

• Applicants will have the opportunity to advocate for the benefit of their selected service areas. King County does not preference a combination of service areas

How will different applications be scored?

 Each application will be given a raw score based on application content. The highest scoring applicant will receive the contract for services they applied for. If necessary, King County will award 1-2 additional contracts to the next highest scoring applicants for the remaining service areas
