Today's Meeting

At today's meeting, the Growth Management Planning Council (GMPC) is scheduled to approve its work plan for 2024.

Overview

A draft 2024 work plan was prepared by the Interjurisdictional Staff Team (IJT) and discussed by the GMPC at its final meeting of 2023. The proposed 2024 work plan includes standard briefings, follow up work from 2023 topics, and some new topics.

Standard briefings

• Includes recurring topics such as biennial annexation updates, annual legislative session updates, and other updates of interest to the GMPC.

Follow-up on 2023 topics:

- 2024 King County Comprehensive Plan Update. Any actions required in conjunction with the 2024 King County Comprehensive Plan Update, including review of any proposed urban growth area changes.
- Affordable Housing Committee work. Updates related to the work of the Affordable
 Housing Committee (AHC). AHC staff began reviewing draft Comprehensive Plans in
 the summer of 2023. As their review continues into 2024, staff will update the GMPC
 on key themes and trends; this could lead to the identification of additional issues for
 GMPC discussion.

New topics

 Growth Target Reconciliation Process: The CPPs direct how growth targets are to be considered in Comprehensive Plans, and provide for the creation of a coordinated countywide 'growth target reconciliation process.' Such a process could be developed in 2024 and implemented in 2025 after statutory updates to comprehensive plans are completed. This work plan item will require amendments to the CPPs. Countywide Centers Designation: The GMPC established a draft list of candidate
 Countywide Centers in 2020 to allow jurisdictions in King County to participate in
 federal transportation funding process coordinated through the Puget Sound
 Regional Council. At that time, GMPC directed that a final list of Countywide Centers
 be designated in 2025 after comprehensive plans are updated. The designation
 process would be established in 2024 and implemented in 2025. This work plan item
 will require amendments to the CPPs. This work will include consideration of any new
 regional centers that need to first be included in CPPs before they can be considered
 by the Puget Sound Regional Council.

The IJT will continue working to ensure that the GMPC's processes are consistent with state law and countywide policy related to tribal participation in countywide planning discussions. This may lead to future GMPC work plan items and discussions.

Shown on the following page is a proposed schedule for how these topics will be presented at the 2024 GMPC meetings.
