The meeting started at 10:05 AM

King County Chief Information Officer Tanya Hannah chaired the meeting.

Welcome and Introductions **10:05 AM**

- Tanya Hannah welcomed the SAC and attendees to the meeting. Each SAC member (or delegate) introduced themselves.

Opening Remarks **10:10 AM**

- Rachel Smith, filling in for Executive Constantine, delivered opening remarks. She expressed gratitude for the work that attendees contributed to providing guidance and advice for the County's technology strategies, planning and implementation, to make King County a welcoming community where every person can thrive. 2020 will be pivotal, and action will shift the course of the future.

Technology Awards **10:17 AM**

- Tanya Hannah introduced the agenda item for presenting the SAC Technology Awards. The fifteen nominated projects advanced the KC Strategic Goals of Public Safety, Healthy Environment/Climate, Equity, Economic Vitality, and Mobility. They also sought outcomes in 3 areas of Connected Communities, Connected Data, and Connected Government. The winners were announced.
 - Digital Evidence. Sheriff Johanknecht accepted the award and noted it was an amazing system for more efficient and effective data storage and sharing.
 - Senior Property Tax Exemption. John Wilson accepted the award and called it an example of One King County. There was collaboration with Assessments, DES and KCIT. There have been 400% more applications this year than previous years.
- Tanya Hannah presented the CIO Award to King County for COVID Response. She applauded the many County employees rising to the challenge.

Recap of October 2019 Meeting **10:25 AM**

- Zlata Kauzlaric provided a recap of the October 2019 meeting
 - October 2019 meeting was about our next Strategic Information Technology Plan for period 2020-2023.
 - SAC was presented three main objectives for the plan and asked for review, advice and endorsement.
 - Connected Communities – We want the Members of the communities to connect with their government and conduct their business from where they are either in person or on-line.
 - Connected Data – Members of the community trust that the data that the County has in their custody provides secure, timely, convenient, and accurate access to their government's services and information.

- Connected Government – Members of the communities use a government marketplace - a quick and transparent access to services regardless of which local or state government provides the service or information.
- SAC members provided input and endorsed the three main objectives of the plan.
- The plan has been transmitted to KCC for their adoption. It is published on KC web site, and the link is included in your pre-meeting materials.

Service Delivery in Disruptive Times **10:30 AM**

- Tanya Hannah introduced the topic of the meeting – Service Delivery in Disruptive Times. She talked about how the Strategic Information Technology Plan gave King County the foundation for service delivery. The County is in a good position to take bold action.
- The pandemic has affected us in many ways. We took the solid foundation and sharpened our narrative. During the pandemic we are leaving some communities behind, the most vulnerable parts of the population still need services. That is where will be sharpening our focus.
- A Zoom poll was conducted “How relevant has technology been for you and your customers this year?” – 97% of respondents indicated “significantly more relevant”
- Technology is woven into the fabric of our lives. The vision is to make King County a welcoming community where every person can thrive.
- Tanya provided her reflection on the accomplishments made in Connected Data, Government and Communities since 2017 when she attended her first SAC as CIO.

SAC Breakout (Reimagining Government in Disruptive Times) **10:55 AM**

- At this point in the meeting, the SAC members broke out into three break out groups in Zoom, to discuss the questions “What are you seeing in your industries, from other clients or peers to help inform our plans and to address gaps?” and “Where are there areas to focus on to support your businesses?”

SAC Breakout Room Debrief **11:10 AM**

- Tanya facilitated a debrief from the breakout sessions asking various SAC members the feedback from their breakout session.
 - Mark Ronaldson said he thinks a lot about the citizen experience, lots of virtual, how to rethink how to engage with citizens. Digital equity is important to be thinking about so that everyone has access.
 - The Sheriff emphasized the importance of being current in the technology that we have and expand to community members, the most vulnerable populations.
 - Leesa Manion said it is important that someone is the architect of the component systems.
 - Tanya emphasized interoperability.
 - Michael Mattmiller also brought up digital equity. Some people have a computer in the household for the first time. We should enable parents to take advantage of scaling opportunities.
 - Viggo Forde said this presents an opportunity to think about changing the customer service interaction. Paperless solutions.
 - John Wilson mentioned non-urban digitization.

- Andrew Cushman emphasized that there are 2 dimensions (internal and external) to automation and self-service.
- Shannon Smith mentioned her group talked about moving from large replacement projects to automation and process optimization to ease the resource crunch
- Tanya thanked everyone for their feedback and segued into the next topic for the meeting: Cybersecurity

Spotlight: Cybersecurity and Privacy **11:20 AM**

- Tanya Hannah introduced the topic of Cybersecurity threats – pandemic, unemployment, protests, before handing the meeting over to Mike Kaser, King County CISO, who led this presentation.
- Mike Kaser presented slides that depicted how the County is thinking and responding to security and privacy threats.
- The focus in March of this year was on Public Health and enabling the agencies to have more connections into the community.
- Now the focus on how to help a large diverse workforce work from home.
- Security and privacy need to be strategic. King County has engaged a consultant that has help us build this framework. King County has also hired a privacy program manager to help understand our privacy maturity level.
- There is more work to do, the threat landscape is fascinating. It is necessary for us to work together. King County has been working with the City of Seattle and State of Washington.
- Andrew Cushman agreed that the attendance is very strong, which indicates the WA CISO meeting is a valuable forum.

SAC Breakout (Cybersecurity) **11:40 AM**

- At this point in the meeting, the SAC members broke out into three break out groups in Zoom, to discuss the question “What cybersecurity and privacy threats do you see and what else should we be doing?”

SAC Breakout Room Debrief **11:50 AM**

- Tanya facilitated a debrief from the breakout sessions asking various SAC members the feedback from their breakout session.
 - Jim Weaver said that with increasing workforce at home, there is a need to strengthen security.
 - Consider turning off devices like Alexa when talking about PII.
 - Andrew Cushman pointed out that cybersecurity is not just a technical problem. Policy makers need to understand. Leesa Manion echoed that leaders need to stay involved.

Final Comments **11:55 PM**

- Tanya thanked the members for coming and asked for any final comments or feedback.
 - John Wilson said that there are challenges ahead. The public has an expectation that we will pick up the pace. COVID-19 has changed how we do business.
