### Turnaround Time for Inspection requests

- You can request an inspection up to five days in advance. Submit your request before 3pm to request next business day inspection.
- The number of requests received for any specific day can vary significantly. Due to this and other factors we may not be able to schedule your inspection on the date requested. An inspector will call you at the contact number you provide if we need to re-schedule the inspection.
- An estimated window of inspection time will be available by self-service after 8am. You may also receive an automated phone message of estimated inspection time if you provided a contact number. Our inspectors cannot provide a guaranteed arrival time.
- **Fire inspections:** Inspection requests are not confirmed until you receive a call from the assigned inspector to schedule a specific date and time.
- **Vashon:** Available on Thursday’s only
