

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist

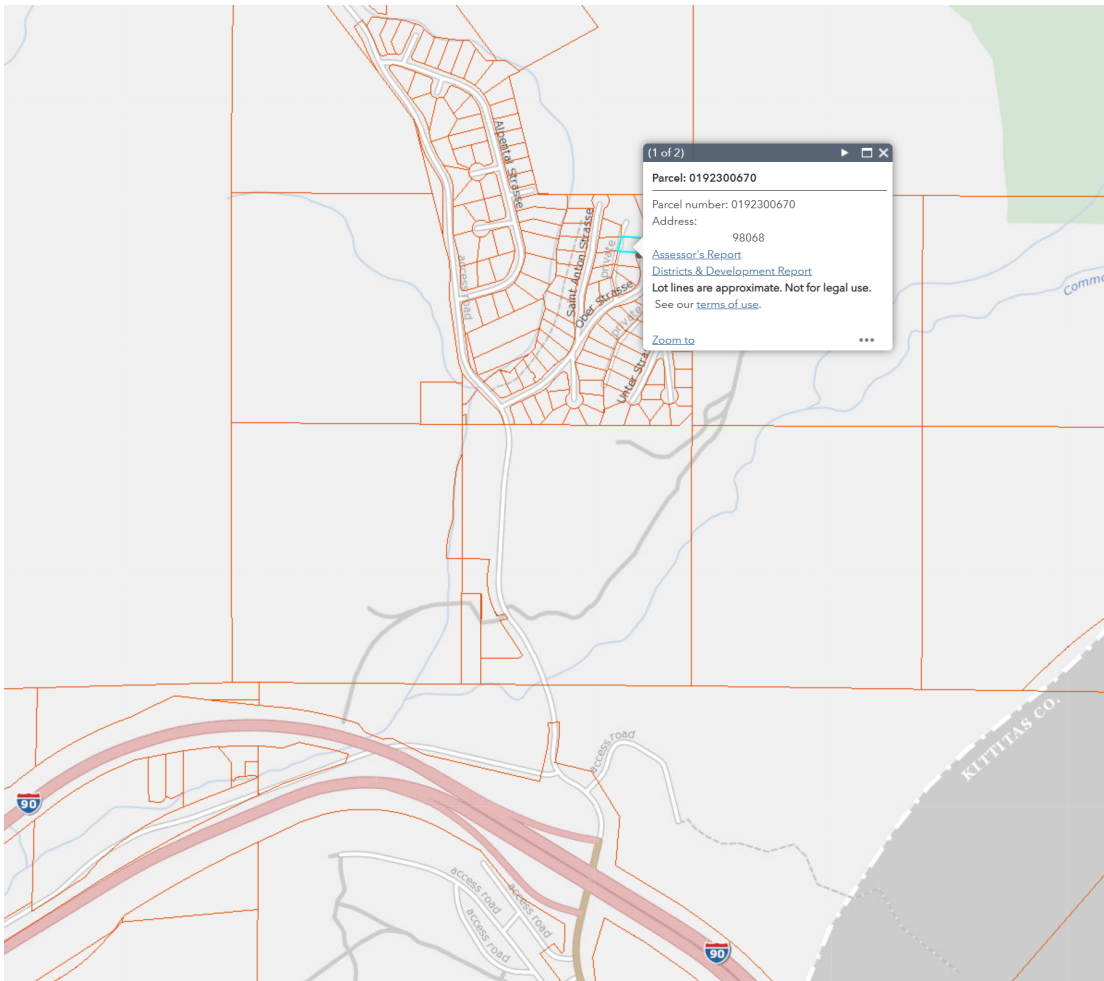

The subject property is a vacant 9,213 SF (.21 AC) parcel in the R-4 Urban Residential zone in the Alpentel Community Club (ACC) under the jurisdiction of King County. Survey indicates 40' of grade change from east to west across the project area. The site is mapped as a potential steep slope hazard area and includes a small portion of potential landslide hazard buffer at the northwest. There are a high number of existing trees on and adjacent to the site. Both adjacent parcels to the north and south have been developed.
