Pursuant to King County Code (KCC) Title 20, public notice is being provided to property owners within 500 feet of the project location.

The Department of Local Services, Permitting Division will issue an Environmental Threshold Determination pursuant to the State Environmental Policy Act (SEPA) on this application following a **21-day public comment period** which ends on **October 17, 2024**. The responsible official has a reasonable basis for expecting to issue a SEPA Determination of Non-Significance (DNS) on this project. The project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared.
