Project Description: The proposal is to mitigate ABC paved over existing gravel driveway and stormwater conveyance system. The stormwater system includes dispersion trenches with 100-200 ft flow path or rock pads with a ditch line that discharges to wetlands. Four wetlands have been delineated and a stream has been classified. The stormwater system will encroach into the stream and wetland buffers.

Permit requested in this application: Clearing & Grading ABC (Type 1 Decision)

Environmental review is required, and relevant environmental documents are available on-line at www.kingcounty.gov/permits, or at the above address.

Consistency with applicable County plans and regulations: This proposal will be reviewed for compliance with all applicable King County codes including Roads Standards, Surface Water Design Manual, Zoning, Grading and Critical Areas Codes.

King County Code requires notification of property owners within at least 500 feet of the project proposed above, so they can obtain additional information about the proposal and comment per KCC 20.20.

The Department of Local Services, Permitting Division will issue an Environmental Threshold Determination pursuant to the State Environmental Policy Act (SEPA) on this application following **a 21-day public comment period which ends on Friday, November 29, 2024.** The responsible official has a reasonable basis for expecting to issue a SEPA Determination of Non-Significance (DNS) on this project. As such, the optional DNS/MDNS notice process is being used pursuant to WAC 197-11-355. The project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared.

This may be the only opportunity to comment on the environmental impacts of the proposal. Written comments on this application must be submitted to Permitting Division at the address above by the end of the comment period.


