Purpose of checklist

This project is a clear and grade permit with wetland buffer mitigation plan for adding paving (impervious) within the existing wetland buffer. This proposal will remove the paving and mitigate for that impact. The property is approximately 12.06 acres and this impact is approximately 0.69 acres.

The steepest slope on the site is over 45%.

- d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.**

None known to exist.

- e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.**

The purpose is to remove existing paving not permitted within the wetland buffer. The property is approximately 12.06 acres. The target area is approximately 30,261 square feet. There is no cut and fill as part of the Clear & Grade permit since the work consists of pavement removal, adding a 2' gravel strip to provide basic and full dispersion for the pavement that will remain, and buffer replanting.

- f. Could erosion occur because of clearing, construction, or use? If so, generally describe.**

Yes, erosion could occur, however the use of BMP's will mitigate possible erosive situations should they occur. Dewatering methods may be necessary during wet, winter months to mitigate moisture content.

- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?**

Approximately 4.6% of the site will be covered with impervious surfaces

- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any.**

Temporary erosion and sedimentation control best management practices (BMPs) and construction water quality treatment measures would be installed to minimize erosion and to treat stormwater runoff during construction. BMPs specific to the site and project would be specified by the project design team in the construction contract documents, and the construction contractor would be required to implement them.

2. Air

During construction, there will be a small increase (approximate quantities are unknown) in exhaust emissions from construction vehicles and equipment and a temporary increase in missions and dust (non-point source) would occur during earthwork for the project. The most noticeable increase in emissions will occur while earth moving is taking place. Exhaust emissions would also be generated from construction worker vehicles and equipment traffic to and from the site. The number of workers at the project site at any one time would vary depending upon the nature and

construction phase of the project. These potential air quality impacts would be temporary in nature, occurring during construction activities. The mitigation listed below, in Section 2.c, would ensure that the effects of construction activities on air quality would be minimized. Upon completion, the project would result in an increase in air quality over existing conditions. Average vehicle emissions are declining due to rapid improved technology.

b. Are there any off-site sources of emissions or odor that may affect your proposal? If so, generally describe.

There are no off-site sources of emissions or odors that would affect the proposed project.

c. Proposed measures to reduce or control emissions or other impacts to air, if any:

The contractor chosen for the proposed project would be required to comply with Puget Sound Clean Air Agency (PSCAA) regulations. Regulations that apply to the proposed project include Regulation I, Section 9.11 prohibiting the emission of air contaminants that would or could be injurious to human health, plant or animal life, or property; and Regulation I, Section 9.15 prohibiting the emission of non-point source dust, unless reasonable precautions are employed to minimize the emissions.

Yes. There are Four wetlands (Wetlands A, B, C, and D) and one stream (Stream 1) are located on the site. The wetland and stream boundaries were surveyed and the delineation and ratings were approved by the County as part of CADS18-0355..

Yes, there will be work that occurs in the wetland buffers. Plans will be supplied as part of the clear and grade permit to the County.

No filling or dredging of surface water bodies are anticipated.

No discharge of waste materials to surface waters would occur. All waste materials from the project, including grading spoils and demolition debris, would be transported off-site to an appropriate disposal facility.

Limited vegetation within the disturbed area boundaries of the site will be removed. See mitigation plan for detail.

The Washington State Department of Natural Resources (WDNR) Natural Heritage Program (NHP) database lists all known occurrences of threatened or endangered species and critical habitat by township-range-section. This project is located within T26N R06E S8. There are no known listed or threatened species or critical area habitats in the surveyed land section for "Sections that Contain Natural Heritage Features".

Further, the database showed no threatened or endangered plant species on or near the project site (WDNR, 2018).

The proposed landscaping is provided through native plants as identified in the vegetative plan.

A review of the WDFW Priority Habitats and Species (PHS) database revealed no priority habitats or threatened or endangered species on or in the vicinity of the project site (WDFW 2018).

Yes, The Puget Sound area is located within the Pacific Flyway, which is a flight corridor for migrating waterfowl and other avian fauna. The Pacific Flyway extends south from Alaska to Mexico and South America. No portion of the proposed project would interfere with or alter the Pacific Flyway.

Wildlife using the site may be disturbed during construction due to increased noise, human activity, and vegetation removal. Wildlife habitat will be slightly reduced overall due to the increased level of human presence during operation. Individuals could be displaced and moved to adjacent similar habitats in the vicinity. Many wildlife species in urbanized areas such as the project site are generally tolerant of human presence and noise and would not be disturbed. The project is not expected to have substantial impacts on wildlife habitat within or near the project site; therefore, no mitigation is required.

None have been observed.

The contractor will submit spill prevention, dust control, and hazardous materials plans as required by the Ecology and King County.
