Project Location: The subject parcel is located about 8 miles east of the City of Enumclaw, in King County, Washington (Parcels 0619089002, 0519089001, 0619089001). Access to the project site is provided via Forest Access Road 5200, a gated private road, which connects to State Route 410.

Project Description: Proposal to approve an expansion to Scatter Creek Quarry for approximately 80 acres of additional disturbed area beyond its existing footprint and re-routing a 2800 feet long portion of Forest Road 5200.

Permit requested in this application: Grading-Mining Permit (Permit record # GRDE24-0001)
