The proposed project is a single-family residential project that will construct five new homes. The existing and proposed use of the project is single-family residential with King County Zoning of RA-5 where the proposed project is allowed.

The project is located at 26920 NE Ames Lake Rd, Redmond, WA 98053. The project is located in a portion of SW ¼, Section 24, Township 25N, Range 06E. There are a total of five parcels included in the project with King County parcel numbers as follows:

- 242506-9102, -9103, -9104, -9105, and -9024.

The project site is approximately 5.1 acres and is somewhat rectangular with dimensions of 250 feet wide by over 800 feet deep. The total area of clearing and disturbance is 2.8 acres. The project site generally slopes from east to west with slopes of approximately 5 to 15 percent. There are no steep slopes or geologically hazardous areas on or near the project site. There are no open bodies of water or creeks on or near the project site.

Silty sand and gravel (weathered outwash) overlain by medium to coarse grained sand with gravel (recessional outwash). The upper weathered soils can be classified as Vashon Glacial Till and deeper soils as Vashon Recessional Outwash and Ice-Kame deposits.

- d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.**

No, none known. The Geotechnical Evaluation did not find any unstable soils.

- e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.**

Approximately 400 cubic yards of cut, 300 cubic yards of fill, with a net earthwork of 100 cubic yards of cut. Earthwork brought into the site will be from local supplier or quarry.

- f. Could erosion occur because of clearing, construction, or use? If so, generally describe.**

Yes, minor erosion could occur during clearing and construction activities, but will be limited and kept onsite by the use of erosion control measures which are part of the grading permit.

- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?**

Impervious surfaces will include house roofs, driveways and access road with a total impervious area of approximately 38,109 square feet (0.875 acres).

- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any.**

Temporary erosion and sediment control (TESC) measures will be implemented during construction per the grading permit. As part of the grading permit TESC plans and a Construction Stormwater Pollution Prevention Plan has been prepared for the project to help guide the contractor on implementing the TESC measures.

During construction typical vehicle and equipment exhaust will be the primary emissions to the air. After construction emissions to the air will be typical for residential properties including passenger vehicles and heating exhaust.

There is an existing well onsite that will remain and be used for irrigation for the new residences.

New septic systems will be installed on each property. Drip dispersal systems will be used discharge domestic sewage. The size of the system will cover approximately 3,000 square feet on each property. The septic systems will be permitted and approved by King County department of health prior to installation.

Source of runoff will include rainfall which will create stormwater on the project site. Stormwater will be managed by collecting and conveying to an onsite retention facility that will infiltrate into the soils. The retention facility will have an overflow that will discharge large storm events to the existing drainage in Ames Lake Rd.

NE Ames Lake Rd is located adjacent to and south of the project site. NE Redmond Fall City Rd (SR202) is located approximately one-mile west of the project site.

The site is not served by public transit. Nearest transit is over one-mile away from the site.

A new private road will access the development and provide vehicular access from NE Ames Lake Rd.

It is estimated that each unit would have about 9 vehicular trips, equating in approximately 45 vehicular trips per day. Peak volumes would occur in the evening with 2 trips per unit, or 10 peak hour trips. The volume of trucks is assumed to be zero percent since these are single-family homes.

- f. Will the proposal interfere with, affect, or be affected by the movement of agricultural and forest products on roads or streets in the area? If so, generally describe.**

The properties will pay taxes that will be used for public roadways.
