Newly disturbed area is approximately 520' long by 60' wide = 31,2000 sf.

Cut = 6004 cubic yards

Fill = 3224 cubic yards

Some erosion could occur. However, there will be a Stormwater Protection Plan (SWPPP) backed up by on site CESCL inspectors as part of the permitted plans.

The source of runoff will be from the newly constructed asphalt/concrete access road and will be directed into stormwater treatment facilities before being conveyed into county stormwater collection devices.

Surface runoff could pick up surface materials. All or most of any water borne surface materials will be filtered by bioswales, sand filters, and rip rap.

No. Stormwater management proposed is designed to maintain or reduce the current historical water flow rates and destinations.

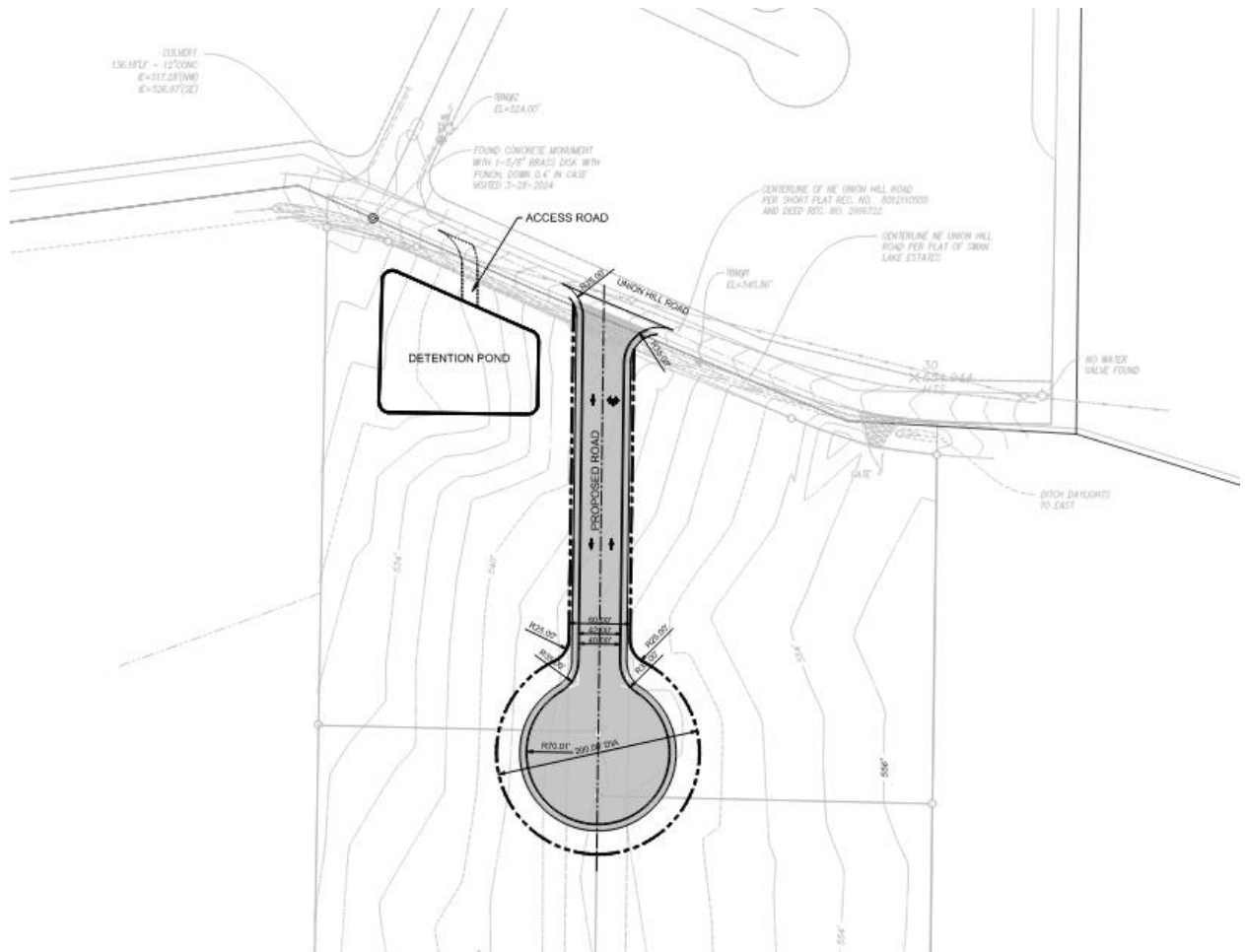
