**Appeal Process:** The Department of Local Services, Permitting Division, will issue a decision on this application following a **14-day public comment period which ends Wednesday, July 22, 2026.**

Written comments on this application must be submitted to Permitting Division at the address above. A public hearing is not required for this application prior to the Permitting Division's decision. However, the decision may be appealed to the King County Hearing Examiner, who would conduct an appeal hearing prior to making a decision on the appeal. Details of the appeal process will be included in the notice of decision.
