Project Description: Repair damage to an existing County revetment on the south fork of the Snoqualmie River by replacing eroded rip rap and constructing a buried setback revetment.

Permit requested in this application: Shoreline Substantial development Permit

King County DNRP, Water and Land Resources Division issued a State Environmental Policy Act Mitigated Determination of Non-Significance for the King County Flood Protection Facility Maintenance and Flood Damage Repair Program (Programmatic SEPA) on May 16, 2007. Written comments on this application must be submitted to DLS-Permitting at the email address above. A public hearing is not required for this application prior to the DLS-Permitting decision. However, the decision may be appealed to the State Shoreline Hearing Board.
