

# SEPA ENVIRONMENTAL CHECKLIST

## **Purpose of checklist**

The Site is an approximately 2.8-acre undeveloped parcel located at the corner of 185th Avenue Northeast and Northeast Woodinville Duvall Road in Cottage Lake, Washington (King County tax parcel 163070-0185). The Public Land Survey System location of the Site is the Northwest  $\frac{1}{4}$  of Section 7, Township 26 North, Range 6 East.

The Site is bordered to the North by Northeast Woodinville Duvall Road, to the East by a developed parcel including a single-family residence, to the South by Cottage Lake and a partially developed parcel containing a single-family residence, and to the West by 185th Avenue Northeast.
