

## **2026 South County Area Transportation Board (SCATBd) State Legislative Priorities**

The South County Area Transportation Board (SCATBd) is a collaboration of local elected officials and stakeholders including: 16 cities in South King and North Pierce Counties; King County; Puget Sound Regional Council; the Ports of Seattle and Tacoma; Pierce Transit and Sound Transit; 826,000 people and over 351,000 jobs; and the 5<sup>th</sup>, 11<sup>th</sup>, 25<sup>th</sup>, 27<sup>th</sup>, 30<sup>th</sup>, 31<sup>st</sup>, 33<sup>rd</sup>, 34<sup>th</sup>, and 47<sup>th</sup> Legislative Districts.

The South County area is heavily reliant on transportation investments to connect roads and transit in South King County and North Pierce County, the area hosts:

- a) an airport with record breaking travel demand,
- b) major industrial hubs,
- c) one of the largest and growing warehousing and distribution centers in the United States.

Moreover, as you know, South King County has a high population of historically underrepresented BIPOC residents and residents earning low-incomes, and we urge the Legislature to invest in the areas listed below.

### **South County area projects are critical to meeting the region's and the state's transportation needs:**

- The South County area's transportation needs have been historically under-served and under-funded. The area hosts essential transportation corridors, is a critical part of the state's economy, and provides access to jobs and affordable housing in one of the fastest-growing regions in the state.
- Ensure Move Ahead Washington package is fully funded.
- Preserve funding to ensure our critical local WSDOT projects get completed.

### **We ask that the Legislature prioritize these key values outlined by SCATBd members:**

- Prioritize maintenance of the state highway system and bridges.
- Provide cities and counties better financing tools to adequately address aged infrastructure and local roadways.
- Support Vision Zero programs and projects to improve safety for pedestrians and bicyclists – especially as data shows crashes and fatalities are increasing.
- Develop an equitable road usage charge (RUC) system to generate necessary revenue to eventually replace the gas tax, fund the state's long-term transportation needs, including multimodal connections and introduce revenue flexibility
- Invest in transit-related priorities including first mile/last mile improvements, parking, and alternative services such as Metro Flex, especially in our smaller, rural communities.

- Increase communication with cities and counties in regard to transferring the state highway system.
- Build on the historic transit investments included in Move Ahead Washington and funded through the “Climate Commitment Act.” South King County is highly transit-dependent and experienced significant ridership even through the COVID- 19 pandemic.

**Siting of a second regional airport is critical:**

- Legislators should act on a second regional airport, for economic development, to relieve congestion around SEA Airport, and to improve air quality, reduce noise, and lessen traffic congestion for surrounding residents.
- Promote collaboration with local jurisdictions on site selection.

**Continue to prioritize investments that reduce impacts of climate change:**

- Support the infrastructure and development of zero emissions heavy vehicles including transit and trucks.
- Support efforts by Northwest Seaport Alliance to implement the Northwest Ports Clean Air Strategy.
- Continue to support local jurisdictions and transit agencies in implementing all zero emission options.
- Support carbon sequestration to help us get to net zero emissions.
