Upcoming site work: Installation of RapidRide I Line Bus Station

Location: 108th Ave SE & SE 200th St, Kent

- **UPDATE (4/3):** work at this location is pending necessary WSDOT approvals; we expect to begin end of this month.

Standard working hour window:

7:00AM – 5:00PM, Monday–Friday

This time is inclusive of quiet prep time, mobilization, set up, cleanup and storage. Weekend and night work may occur. Advanced notice will be provided.

*Anticipated impacts: (see back to see map)

- Right lane closure on northbound 108th AVE SE (WA 515), from approximately SE 201st St and SE 200th St
- East Sidewalk Closure from SE 200th St to SE 201st St

*Note: Timelines may shift due to weather or unexpected delays. Please check our project page or contact the team for real-time updates.

Project Background: King County Metro will upgrade Route 160, which currently runs between Renton, Kent and Auburn – to future RapidRide I Line. RapidRide is part of a larger, system-wide approach to improve transit access in south King County, and I Line service is planned to begin in 2027.

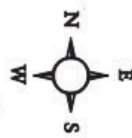

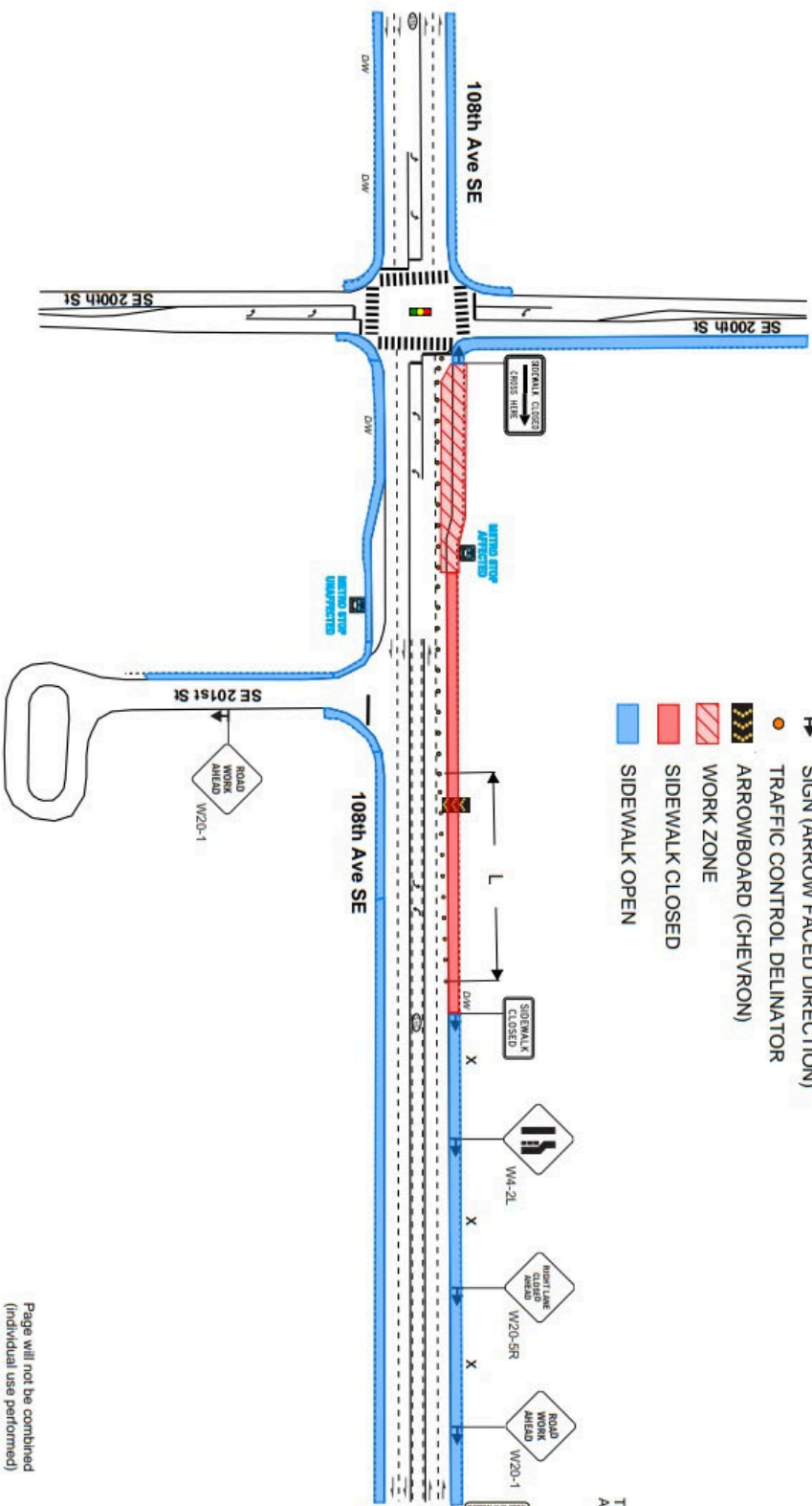
