Re: Fatality Investigation of Juan Salamanca Acosta

Dear Executive Constantine:

The King County Prosecuting Attorney's Office has received and reviewed the investigative materials from the Renton Police Department concerning the motor vehicle fatality of Juan Salamanca Acosta on October 27, 2019.

In accordance with Executive Order PHL-7-1-5-EO §7.1, we are satisfied that the investigation is now complete. In addition, under PHL-7-1-5-EO §7.1, we are required to advise whether an inquest should be initiated pursuant to the King County Charter §895.

The King County Charter requires a mandatory inquest "where an action, decision or possible failure to offer the appropriate care by a member of any law enforcement agency might have contributed to an individual's death." Given the circumstances, we have little information to determine whether a law enforcement action or decision contributed to Mr. Acosta's death; the only person who would know is the deceased Mr. Acosta.

"Might have contributed . . ." is a low standard. We are deferring to your discretion under PHL-7-1-5-EO §6.1, which permits you to decide an inquest need not be initiated if you determine that the role of law enforcement was de minimis and did not contribute in any discernible way to a person's death.

Per PHL-7-1-5-EO §8.4, upon your request, we will forward the investigative file to the Inquest Program Manager. Such requests can be sent to <u>PAOPublicIntegrity@kingcounty.gov</u>.
