Dear Executive Constantine:

The King County Prosecuting Attorney's Office has received and reviewed the investigative materials from the Seattle Police Department, concerning the death of Jaahnavi Kandula on January 23, 2023.

In a memorandum dated February 21, 2024, the KCPAO "determined that it cannot file felony charges against Seattle Police Department (SPD) Officer Kevin Dave for the events relating to SPD case #2023-22231 because there is insufficient evidence to prove felony charges beyond a reasonable doubt."

In accordance with Executive Order PHL-7-1-5-EO §7.1, we are satisfied that the investigation is now complete and recommend that an inquest be initiated pursuant to the King County Charter §895, which requires a mandatory inquest unless, under PHL-7-1-5-EO §6.1, you determine that the role of law enforcement was de minimis and did not contribute in any discernable way to a person's death.
