Waa maxay Magdhow?

- Maxkamadu waxay amartaa magdhawga kadib marka eedeysnaaya la xukumo.
- Waxaa muhiim ah in Bayaanka Waayitaanka Dhinaba yo dhamaan waraaqaha xoojinta ah lagu soo celiyo Qaybta Kaalmada Dhibanaha *sida ugu dhakhsaha badan* si markaa xafiiskeenu u eegi karo waraaqaha oo u diyaarin karo amarka xukunka si loo akhriyo oo loo saxeeyo.
