## WHEN TO CONSIDER AN ERPO

- Recent threats or acts of violence toward self / threats of suicide
- Recent threats or acts of violence toward another person or group
- Pattern of behavior suggesting an immediate danger to self or others
- Dangerous use or display of firearms
- Past threats or use of physical force, or history of stalking
- Protection Order or No Contact Orders violations
- Prior or active ERPOs, including any violations
- Criminal convictions of domestic violence or hate crimes
- Evidence of the abuse of controlled substances or alcohol
- Owns, plans to buy, or recently bought a firearm with any of these risks present



## WHAT DOES AN EXTREME RISK PROTECTION ORDER DO?





A judicial officer will review the petition to see if the situation meets the legal standard for an ERPO.



If granted, the person must immediately give their firearms and CPL(s) to law enforcement to hold while order is in effect.



The person cannot own, possess, purchase, or access firearms and CPLs for one year.



The court may order a behavioral health evaluation.



If risks remain, the petitioner can request a renewal. The restrained person will be notified of the renewal request and can attend the hearing.

### WHO CAN APPLY FOR AN ERPO?

FAMILY, HOUSEHOLD MEMBERS, & INTIMATE PARTNERS

- Current or former spouse / domestic partner
- Parents of a child in common
- Current/former dating relationship
- Parent or child
- Stepparent or stepchild
- Grandparent or grandchild
- Parent's intimate partner or child
- Current or former cohabitants as roommates
- Person who is or has been legal guardian
- Related by blood or marriage

#### LAW ENFORCEMENT

- Law Enforcement Officer
- Law Enforcement Agency

## AN EXTREME RISK PROTECTION ORDER DOES NOT:



Stop the person from contacting you, coming to your home, or other personal restraints



Filing an ERPO does not initiate criminal charges. However, the underlying behavior may prompt investigation.
