Ex Parte Court Customers:

The following is additional information regarding the transition to the new Ex Parte calendars.

We are currently in the process of adding the new calendar slots to our scheduling system and hope to have all calendars entered within the next week. Although the new calendar will be in place starting the week of **March 10th**, we are aware that there are remote Probate/Guardianship hearings noted through **March 24th** and to cause the least disruption as we make this transition, the court will hold remote hearing as scheduled through that time. The in-person Probate/Guardianship calendars will begin to appear as of March 24th.

The remote Probate/Guardianship calendars on Mondays and Tuesdays will consist of cases set by Case Schedule, Special Set or court order. Additional remote spots may become available depending on volumes.	Unlawful Detainers not resolved at the 1 st appearance will be assigned to the two designated UD judges as well as other available SC judges.
Ex Parte Commissioners will be hearing 1 st appearance Unlawful Detainer cases only. These hearings will take place each morning M-F by video.	Motions for telephonic appearances will not be required as the request can be made at the hearing to include other necessary participants.
Minor settlement currently set through March 24 will proceed as scheduled. On the new calendar they will be set on the Civil Motions/Other calendars.	The court will be exploring a possible rule change to allow Minor Settlement orders to be presented without hearing.
The court is currently in the process of updating the Note for Hearing form, but customers can use the existing one (revising as needed) until a new one is available.
