**Dear Parents:** 

Enclosed is the CO-PETITION FOR MEDIATION document. **Each parent must independently sign this document.** The <u>second and final party</u> who signs this document is responsible for returning it to FCS immediately in order to initiate this process, indicating their willingness to enter into mediation with Family Court Services.

Please keep in mind that mediation at FCS is for PARENTING PLAN ISSUES ONLY. **Family Court Services does not mediate financial matters.** 

There is a sliding fee scale for our services, and the participants will be billed accordingly pursuant to King County Code 4A.632.030 (see enclosure). Each party will be charged a portion of the fee based upon their net income unless a fee reduction/waiver is granted by an administrator at Family Court Services.

Please be aware that all parties are required to attend a mandated seminar entitled, "What About the Children?" However, if you have already attended this class in the past, please submit a copy of your certificate along with this co-petition.

NOTE: If you have an Order of Protection, mediation may not be appropriate. At its discretion, FCS may assess each case to determine if it is appropriate for mediation and will screen out cases if it is determined that mediation should not occur. You will need to make sure that contact with the other party in mediation is not a violation of your protection order. It may be necessary for you to go to court for a specific order to allow mediation.
