**FAMILY LAW TRIAL SELECTION

You must file this form to indicate whether you want a Traditional Trial or an Informal Trial. This form must be filed by the date of your pre-trial conference or fourteen calendar days before the trial date. There is information that explains the differences between the two kinds of trials available at www.kingcounty.gov/courts/superior-court/family/fl-trials.aspx. A brief description is below:

- *In a Traditional Trial, both parties are allowed to call witnesses and to cross-examine the witnesses appearing on behalf of the other party. The Rules of Evidence apply.*
- *In an Informal Trial the Judge, not the parties, questions the witnesses, the Rules of Evidence do not apply, and there are limits on the ability to call witnesses. This is governed by Local Family Law Rule (LFLR) 23.*

Foomkan waa in maxkamadda loo soo gudbiyaa dhegeysiga ka horeeya dhageysiga ugu dambeeya ama afar iyo toban cisho ka hor taariikhda dhageysiga. Waxaa jira macluumaad faahfaahin ka bixinaya faraaqa u dhaxeeya labada dhageysi oo aad ka heli karto www.kingcounty.gov/courts/superior-court/family/fl-trials.aspx. Faahfaahin kooban halkan ka akhri:

- *Dhageysiga Habkii Hore, labada dhinacba waxaa loo ogol yahay in markhaatiyaashooda maxkamadda keenaan oo su'aalo weydiin karo dhinac kasta markhaatiga kan kale. Sharciyada Cadeymaha ayaa la raacayaa.*
- *Dhageysiga aan Rasmiga Aheyn qaaliga, ma aha dhinacyada, ayaa su'aalo weydiya markhaatiyaasha, Sharciyada Cadeymaha lama raaco, waxaana kooban ogolaashaha u yeerista markhaatiga. Tan waxaa lagu maamulaa Dhariyada Dacwadaha Qoyska ee Degaanka (LFLR) 23.*

Ka haridda Dhageysiga in loo qabto Habkii Hore *Haddii aad bogga 1 ku cadeysay in aad dooneyso dhageysi aan rasmi aheyn, waxa aad ogolaatay qodobada soo socda:*

- I agree to waive the normal question and answer format of trial and I agree the court may ask me questions about the case.

Waxa aan ka harayaa habka su'aalaha iyo jawaabaha ah ee dhageysiga waxa aanan ogolaaday in qaaligu su'aalo i weydiyo ku saabsan dacwadda.

- I agree to waive the use of the Rules of Evidence in this Informal Trial.

Waxa aan ogolaaday in aan isticmaalka Sharciyada Cadeymaha Dhageysiga Aan Rasmiga Aheyn.

- I agree that the other party can submit any document or other evidence they want the judge to review.

Waxa aan ogolaaday in dhinaca kale ay soo gudbin karaan wixii qoraal ah ama cadeymaha kale ee ay doonayan in qaaligu eego.

- I agree that the other party can tell the court anything they feel is relevant.

Waxa aan ogolahay in dhinaca kale uu maxkamadda u sheegi in ay tahay mid aan loo baahneyn.

- I agree to be bound by the procedures of LFLR 23, the rule on Informal Family Law Trials.

Waxa aan ogolahay in la raaco nidaamka LFLR 23 ee sharciyada Dhageysiga Aan Rasmiga Aheyn ee dacwadaha Qoyska.

I understand the following:

Waxa aam fahamsanahay sida soo socota:

- My participation in an Informal Trial is strictly voluntary, and no one can force me to agree to this process.

Ka qeyb qaadashada aan ka qeyb qaato Dhageysiga Aan rasmiga Aheyn waa mid aan khasab aheyn, cidina iguma khasbi karto in aan raaco nidaamkan.

- The court will determine what weight will be given to documents, physical evidence, and testimony that is entered as evidence during the Informal Trial.

Qaaliga ayaa go'aan ka gaaraya muhimadda la siinayo qoraalada, cadeymaha, iyo markhaatiyaasha cadeyn ahaan loo dhageysanayo inta uu socdo Dhageysiga Aan rasmiga Aheyn.

Waxa aan dib u eegay qoraalada maxkamadda ee ku saabsan [Family Law Trials in King County \(Dhageysiga Dacwadaha Qoyska ee Degmada King\)](#) aniga oo fahamsan sida Dhageysiga Aan Rasmiga Aheyn loo qaaado.

- I have not been threatened or promised anything for agreeing to this Informal Trial process.

Cidina iima geysan handadaad ama balanqaad si aan u ogolaado nidaamka Dhageysiga Aan Rasmiga Aheyn.

- I understand that most of the time, the two people in the case are the only witnesses in an Informal Trial. Sometimes a party needs an expert witness (someone with special training and education) to give an opinion, which is allowed in informal trials. The parties may ask experts questions.

Waxa aan fahamsanahay in waqtiga intiisa badan, in labada qof ee dacwaddu u dhaxeeyso ka hadlayaan Dhageysiga Aan Rasmiga Aheyn. Mararka qaarkood waxaa dhici karta in dhinac uu u baahdo markhaatiga qof khabiir ah (qof aqoon ama tababar gaar ah leh) oo ra'yi ka dhiiban kara, kaasoo loo ogolaado Dhageysiga Aan Rasmiga Aheyn ee Dacwadda Dhinacyada dacwada u dhaxeeyso su'aalo ayey weydiin karaan khabarada.
