How do I request a copy of my Juvenile Court records?

You can access your Juvenile Court records online (*for cases from November 1, 2004-forward*), in person, or by mail.

To access records online, use the KC Script Portal Juvenile Offender Cases search.

• Search by case number, filing date, and/or name.

You do not need case number to search, but if you have a common name, make sure you choose the correct cases when your results appear.
