The Court finds that the respondent has willfully violated the requirements or conditions of the order as follows:

- Failing to attend scheduled appointments with the Juvenile Probation Counselor
- Failing to reside in housing approved by his/her parent or guardian or in placement authorized by Department of Social and Health Services or the court and/or to inform the JPC of a change of address or placement.
- Failing to have parent/guardian permission regarding whereabouts, curfew, hours and activities
- Using or possessing a non-prescribed drug or alcohol
- Failing to attend evaluation, treatment, counseling, or classes as ordered by the court or directed by JPC
- Failing to perform community service hours as directed by JPC
- Failing to attend school, with no unexcused absences, tardies, suspensions, expulsions or behavioral referrals
- Committing a new criminal law violation
- Failing to pay legal financial obligations as required

## ORDER

It is hereby ordered, adjudged, and decreed that:
