Capital Projects Oversight: 2020 Biennial Report

IMPROVING CAPITAL PROJECT PERFORMANCE AND ACCOUNTABILITY

The Capital Projects Oversight Program provides focused, independent oversight to promote accountability and improved performance of King County's capital endeavors and to provide timely and useful information to policy- and decision-makers. All program costs are funded through the Capital Improvement Project (CIP) budget. There is some overlap between this work and that of the Metro Transit Audit Program.

Capital Projects Oversight in 2018 and 2019

In 2018 and 2019, we focused our work on the County's highest risk capital projects and programs. We worked closely with those project teams to identify issues early and make plans to address them. Our work included closely monitoring the Puget Sound Emergency Radio Network (PSERN) project and identifying steps to address emerging risks, tracking Metro Transit's progress in meeting its targets for an ambitious capital program to meet growing service demands, and evaluating required actions in response to the 2017 systems failure and catastrophic flooding at the West Point Treatment Plant.

We carefully monitored several other projects, such as the Children and Family Justice Center, the Georgetown Wet Weather Treatment Station, the Joint Ship Canal Project, Courthouse and Civic Campus Planning, and the Algona Transfer Station. In concert with the Office of Performance, Strategy and Budget, our office facilitated the scoring of 105 capital projects to help determine which projects may face the most risk.
