I. CALL TO ORDER

Chair Stephen Toy convened the meeting at 7:03 P.M.

III. PUBLIC COMMENT

There were no public comments.

IV. MINUTES

REGULAR MEETING – NOVEMBER 13, 2025

Chair Toy presented the minutes of the Regular Meeting of November 13, 2025, for review and action by the members.

Action: Jay Hamlin moved and Matthew Everett seconded the motion to adopt the draft minutes for the Regular Meeting of November 13, 2025.

Board members voted eight in favor of approving this record of the Regular Meeting.

REGULAR MEETING – DECEMBER 11, 2025

Chair Toy presented the minutes of the Regular Meeting of December 11, 2025, for review and action by the members.

Action: Jay Hamlin moved and Chandler Felt seconded the motion to adopt the draft minutes for the Regular Meeting of December 11, 2025.

Board members voted seven in favor of approving this record of the Regular Meeting. Teresa Platin and abstained as she did not attend the December 11, 2025, Regular Meeting.

V. ADMINISTRATION

A. CHAIR'S REPORT

There was no Chair's report.

B. EXECUTIVE SECRETARY’S REPORT

Ms. Miklethun shared that final 2025 payments had been made to Members and that she hoped that the new payment process would result in expenses not being included in Members’ 2025 1099s. She then reported that Executive Zahilay had taken office and had begun to recruit, hire and onboard his new staff. She added that several members of the Regional Planning team would continue to work for the County for at least several months. She then reported that the Board has several applicants for its vacant positions and that she would be working with the appointing bodies regarding those positions. Finally, she provided a general update of ongoing work of the Office, such as supply ordering, payments and collaboration with interested parties.

C. COMMITTEE REPORTS

1. BUDGET COMMITTEE

Budget Committee Chair Jay Hamlin shared that the Board spend 94% of its 2025 budget. He highlighted several line items with overspending, including dues/memberships, legal services and training and explained underlying causes for each. He then shared areas of underspend including GIS services, license fees and purchased transportation – i.e., member-related expenditures. Next, he thanked Staff and Members for their ongoing work on the budget. Finally, he reported that the Board’s requested 2026-2027 requested biennial budget had been approved as requested.

2. LEGISLATIVE COMMITTEE

Legislative Committee Chair Mary Lynne Evans reported that the Legislative Committee will be meeting in order to discuss potential amendments to King County Code Chapter 13 regarding water and sewer plans that could affect the Board. Ms. Miklethun added that the Committee could choose to provide feedback regarding the proposed changes as an interested party should it wish to do so. She added that she appreciated County staff including the Board in its outreach process.

WSABRB Legislative Committee Chair Chandler Felt shared that the WSABRB Legislative Committee has begun to meet and discuss the upcoming legislative session. He added that there have not yet been any pre-filed bills that would affect boundary review boards. Next, he reported that the Committee would again be planning a legislative visit to Olympia in order to meet with legislators and share information with them regarding BRBs.

Board members voted eight in favor of approving the committee structure and membership as described above.

VII. DISCUSSION AND POSSIBLE VOTE FOR CHAIR ELECT 2026/CHAIR 2027

Jay Hamlin stated that he would be willing to serve as Chair-Elect/2027 Chair. Members thanked him for his willingness to serve.

Action: Ken Hearing moved and Matthew Everett seconded the motion to appoint Jay Hamlin to the position of 2026 Chair-Elect/2027 Board Chair.

Board members voted eight in favor of appointing Jay Hamlin to the position of 2026 Chair-Elect/2027 Board Chair.

VIII. CHAIR TRANSITION

Chair Toy thanked the Members for their support of him as Chair over the year and expressed how much he had enjoyed working with everyone during his tenure. He also thanked Ms. Miklethun for her support. The Members and Ms. Miklethun thanked Chair Toy for his service and remarked on the great job he did as Chair. Chair Toy then passed the Chair's gavel to Cheryl Scheuerman. Chair Scheuerman expressed her excitement for working with Members and Staff in 2026.

IX. NEW BUSINESS:

A. NEW FILE [2422](#)

The Board received a Notice of Intention (File No. 2422) submitted by the King County Drainage District No. 5-5A (the District.) Members received a [Summary](#) of File No. 2422 prior to the meeting. Ms. Miklethun shared King County iMap mapping of the area, and the Members discussed the file.

Ms. Miklethun relayed that the District proposes to withdraw from territory within the City of Enumclaw (the City.) Ms. Miklethun explained that the District intends that the City take over both the work of the District and the District's assets in that area. She added that should this proposal proceed and take effect, the District's current commissioners would need to resign as they live within the City, and, therefore, could no longer serve as they would live outside of the District's boundaries. Further, the County would need to appoint new commissioners that live within the District's new borders. Additionally, Ms. Miklethun reported that there is potentially a discrepancy with the NOI's legal description in that it does not address the District's desire to withdraw from the Sierra Vista Potential Annexation Area which lies outside of the City's boundary. Finally, Ms. Miklethun noted that from its resolution regarding the proposal, it is unclear if the City is aware of the discrepancy regarding the legal description.

Members discussed the Notice of Intention in detail. After doing so, Members directed Ms. Miklethun to work with Chair Scheuerman to draft and send a letter to the District requesting additional information and to clarify and resolve the issue regarding the legal description. Ms. Miklethun stated that she would do that and also request a list of parcels as well as acreage information regarding the proposal. She added that she would post the letter and the District's response to the Board's website.

B. THE MASTERLIST

Ms. Miklethun noted that the Masterlist needs to be updated with the acreage and parcel information from File No. 2422.

C. UPCOMING ACTIONS

Ms. Miklethun relayed information regarding upcoming annexation activity.

X. ADJOURNMENT

Chair Scheuerman adjourned the Regular Meeting at approximately 8:53 P.M.

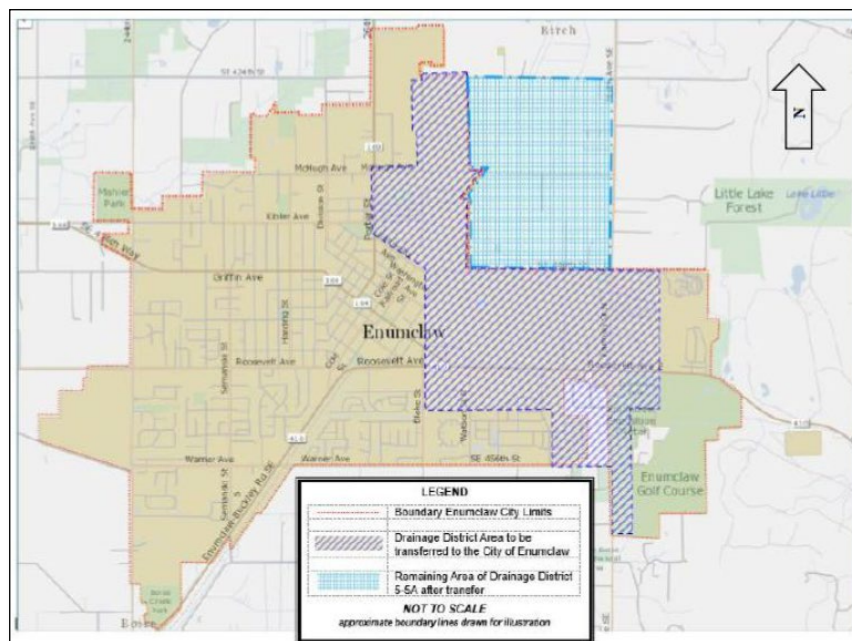

Dear Mr. Reynolds:

Thank you for your call on Monday, January 12, 2026. As I mentioned to you, I am following up regarding some concerns Boundary Review Board Members posed during their discussion of its [File No. 2422](#) regarding the [Notice of Intention](#) (NOI) that you submitted on behalf of King County Drainage District 5-5A (the District.) Additionally, I need to alert you to an important technical issue related to the legal description and mapping.

Based upon the mapping provided by the District in the NOI (Page 10 – see below,) it is my understanding that the District intends to withdraw from territory located both within the incorporated City of Enumclaw as well as territory located in the unincorporated area of King County, specifically the area located in the Sierra Vista Potential Annexation Area.



However, after further review by King County GIS Staff, it has come to the Board's attention that *the legal description (Pages 38-45) submitted by the District with its NOI limits the territory identified for withdrawal as the territory only located within the incorporated City of Enumclaw*. As submitted, the legal description may leave the District with two noncontiguous areas of territory. Therefore, the District needs to clarify the territory it seeks to be withdrawn and submit corrected mapping and/or a corrected legal description as soon as possible, and well before the February 20, 2026, 45-day notice period end date.

The Boundary Review Board Members also discussed several concerns regarding the NOI at its January 8, 2026 Regular Meeting, and the Board would invite the District to respond in writing. Specifically, Board Members would appreciate that the District provide information regarding how this proposal would advance the District's policy goals. Board Members would also like to know more about the work of the District and how this proposal would affect community members of the area of the District located in the City of Enumclaw as well as community members in the area that the District proposes to retain within its corporate boundaries. Further, Board Members question how a reduction in District revenues would impact the District's ability to provide services in the area that it proposes to retain. Lastly, Board Members are interested in the specific concerns identified by the community as referenced in the Minutes of the District's June 9, 2025, meeting as well as the District's response to those concerns.

Further, the following information is needed from the District for reporting requirements to the King County Growth Management Planning Council. Please provide the following information as soon as possible:

- A list of parcels that comprise the territory from which the District proposes to withdraw
- The total acreage of the territory from which the District proposes to withdraw

On behalf of the Board, I thank you for your prompt attention to these matters. As I also mentioned in our call, the deadline to invoke the Boundary Review Board's jurisdiction in this matter is February 20, 2026. Should that not happen by that date, the Board will close its file on February 23, 2026. As this pending deadline adds urgency to this matter, I request that the District expedite the Board's request.

Please let me know if you have any questions or would otherwise like to discuss this matter further.

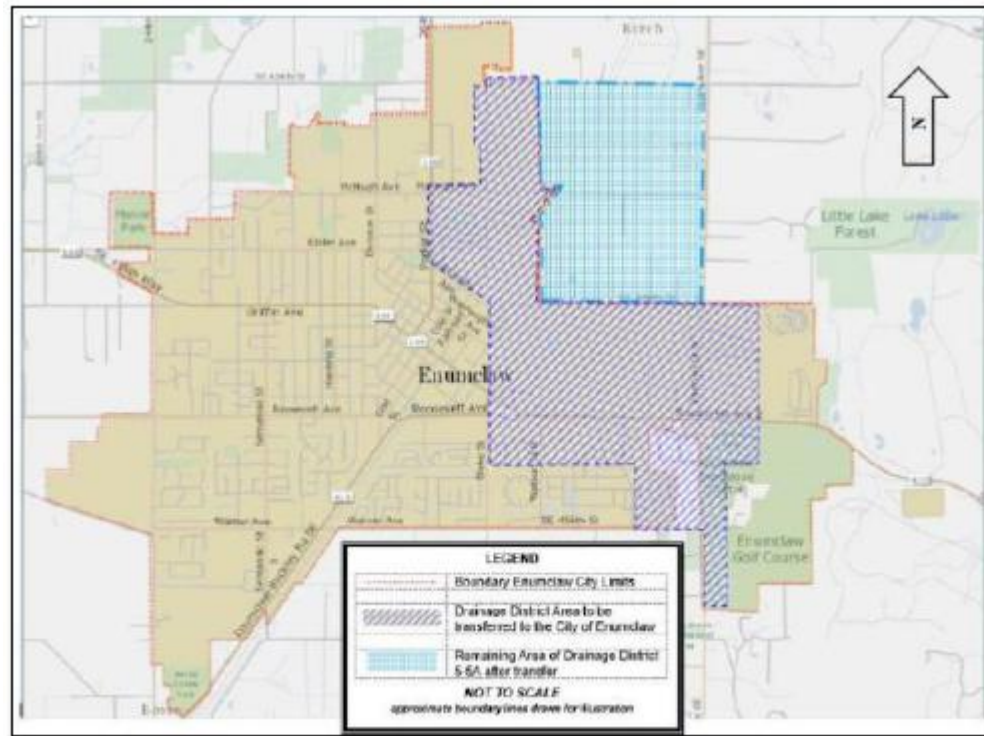

Response to Boundary Review Board questions of January 15, 2026:

1. Based upon the mapping provided by the District in the NOI (Page 10 – see below), it is my understanding that the District intends to withdraw from territory located both within the incorporated City of Enumclaw as well as territory located in the unincorporated area of King County, specifically the area located in the Sierra Vista Potential Annexation Area.



However, after further review by King County GIS Staff, it has come to the Board's attention that *the legal description (Pages 38-45) submitted by the District with its NOI limits the territory identified for withdrawal as the territory only located within the incorporated City of Enumclaw*. As submitted, the legal description may leave the District with two noncontiguous areas of territory. Therefore, the District needs to clarify the territory it seeks to be withdrawn and submit corrected mapping and/or a corrected legal description as soon as possible, and well before the February 20, 2026, 45-day notice period end date.

District's Response:

- a) The District has contacted our Surveyor Service and requested that a legal description for the non-contiguous area be drafted.
- b) The District's proposed action is to withdraw the approximately 48.28 acres of land, comprised of 41 parcels, to be included in the withdrawal of parcels located within the incorporated city limits of the City of Enumclaw. (See response **Exhibit A**).

The Boundary Review Board Members also discussed several concerns regarding the NOI at its January 8, 2026 Regular Meeting, and the Board would invite the District to respond in writing.

2. Specifically, Board Members would appreciate that the District provide information regarding how this proposal would advance the District's policy goals.

District's Response:

- a) Fiscal responsibility to the constituents of the District has been a primary focus of the current Board of Commissioners, following the federal criminal charges and conviction of a former commissioner and his spouse, involving the misappropriation and theft of District funds.

In analyzing the fiscal and financial responsibilities to the District's constituents, the Board of Commissioners recognized that property owners in the District, both in incorporated and unincorporated lands, have been subject to assessments that could constitute double taxation.

Parcel owners within the incorporated city limits of the City of Enumclaw are assessed a monthly Stormwater Fee. A single-family detached residential property pays a monthly fee of \$12.00. Other developed properties pay a monthly fee of \$12 per 3,200 square feet of impervious surface. It is a neglect of fiscal and financial responsibility to property owners for the District to assess properties within the incorporated city limits a fee, for which the city is collecting, to develop and maintain stormwater utilities within the city limits, for which the city is responsible. For this reason, the District has not assessed a Drainage District fee since 2024. The way to correct this situation is to withdraw the parcels within the incorporated city limits from the District.

Parcel owners within the unincorporated area of the district are assessed with an annual Surface Water Management (SWM) fee. In 2025, a 12,039-square-foot parcel located within the District's boundaries¹ was assessed an annual SWM fee of \$361.00. This same parcel, when last assessed for an annual Drainage District assessment in 2024, had an annual assessment of \$46.08.

- b) Fairness to the constituents is a policy value practiced by the District. Property within the city limits has higher building density and greater amounts of impervious surfaces than the predominantly undeveloped farmlands in the unincorporated area of the District. The higher development density within the city limits demands greater and more complex stormwater infrastructure and more costly maintenance. The properties within the incorporated city limits should bear these higher costs through the City's Stormwater Fees and not have them subsidized by the assessments paid for by member properties of the District within the unincorporated area.

An example of this situation involved a capital project to replace underground stormwater infrastructure within a commercially developed area inside the incorporated city limits. The total cost of the project was slightly under half-a-million dollars. The Board of Commissioners successfully secured grant funding to cover much of the project's cost; however, if the grant had not been awarded, the District's constituents would have borne the entire cost to benefit a long-established, commercially developed area within the incorporated city limits, that would have afforded no benefit to the majority of the District, especially those in the unincorporated area.

3. Board Members would also like to know more about the work of the District and how this proposal would affect community members of the area of the District located in the City of Enumclaw as well as community members in the area that the District proposes to retain within its corporate boundaries.

District's Response:

- a) Those properties within the incorporated city limits would continue to see maintenance and improvements performed by the City of Enumclaw, and funded through the City's Stormwater Utilities Fee, which these property owners are already being assessed on a monthly basis through the city's monthly utility billing.
- b) Those properties within the remaining unincorporated area would continue to function as a Drainage District, provided there are property owners within the remaining area with an interest in serving as Commissioners and continuing the work of the District. As part of this process, multiple mailings have been sent to property owners in the unincorporated area of the District, inviting them to apply to become a Commissioner and serve the District. To date, we are only aware of one person who has contacted Councilmember Dunn's office to express interest. If the District's constituents chose not to serve and elect commissioners, the District's operations would be suspended until persons came forward to serve, or the District dissolved in accordance with RCW. If the District dissolved, individual property owners could maintain drainage ditches across their property as they do within the majority of land in unincorporated King County, and/or King County would maintain those ditches with funding presumably collected from the SWM fees collected from those properties.

4. Further, Board Members question how a reduction in District revenues would impact the District's ability to provide services in the area that it proposes to retain.

District's Response:

- a) The remaining District is serviced primarily by open ditches, with few underground culverts that allow farmland access across ditches traversing open agricultural fields. Maintaining open ditches is lower cost than underground infrastructure, and there is no infrastructure replacement cost.
- b) In each year, 2019 through 2024, the District levied a total assessment of \$108,400 against the parcels of the District. The amount assessed annually from those parcels that will remain in the District was \$14,242.54.
- c) The District has a current End Fund Balance of \$115,743.27, with minimal anticipated costs between now and the completion of the proposed action. The balance of funds will remain with the District.
- d) A newly appointed/elected Board of Commissioners will have the authority to establish budgets and assessments to continue the maintenance work necessary for the function of the District.

5. Lastly, Board Members are interested in the specific concerns identified by the community as referenced in the Minutes of the District's June 9, 2025, meeting as well as the District's response to those concerns.

District's Response:

In response to the 687 Notices of Public Hearing mailed to each property owner of the District, the following comments were read or received as follows:

- a) Jennifer Coffey Morely, via email, requested an electronic copy of the map provided in the mailed Notice of Public Hearing. Her property is not within the District. She asked for information about a well on her property that had been decommissioned by a previous landowner.
- b) John Morris via email and presented at the Public Hearing. Mr. Morris owns several properties within the District, each of which is within the incorporated city limits. He expressed concern that his city's stormwater bill could increase to cover costs previously collected by the District through the annual assessment.

- c) David Dietz via email. Mr. Dietz owns property within the District. He requested an electronic copy of the map provided in the mailed Notice of Public Hearing. He wrote that he supports the proposal, but asked if, in lieu of electing a new board of commissioners, the remaining District could be combined with Drainage District 13.
- d) Bart Jensen presented at the Public Hearing. Mr. Jensen owns several properties within the District, each of which is within the incorporated city limits. He inquired whether a Drainage District assessment would still be charged to properties within the incorporated city limits and asked if previously collected drainage district assessments would be returned to property owners.
- e) Beau and Roberta Kranz presented at the Public Hearing. They own property within the incorporated city limits. They asked questions about the drainage district's maintenance history and future maintenance plans. They requested that the District address debris that was left by the contractor along the ditch through their parcel as a result of the recent ditch maintenance.
- f) Enumclaw City Administrator Chris Searcy presented at the Public Hearing. He shared that the City Council has approved a Resolution of Intent to enter into an agreement with the District to facilitate the transfer of District properties, easements, rights-of-way, and infrastructure within the incorporated city limits, once approved by the Boundary Review Board.
- g) Other than those identified above, the Commissioners and District Counsel, only one other person attended the Public Hearing. He was invited to ask questions or present comments, but declined.

Further, the following information is needed from the District for reporting requirements to the King County Growth Management Planning Council. Please provide the following information as soon as possible:

- 6. A list of parcels that comprise the territory from which the District proposes to withdraw.

District's Response:

- a) Response **Exhibit A**, as addressed on page 1, lists 41 parcels, an area of approximately 48.27999935 acres, that are within an unincorporated area of the District, surrounded on three sides by the incorporated city limits of the City of Enumclaw, that are proposed to be withdrawn from the boundary of the District.

- b) Response **Exhibit B** lists the 616 parcels, an area of approximately 804.15999945 acres, that are within the incorporated city limits of the City of Enumclaw. These parcels are to be withdrawn from the boundary of the District.

7. The total acreage of the territory from which the District proposes to withdraw.

District's Response:

- a) The total acreage of the parcels to be withdrawn from the District is approximately 852.44 acres.

ADDITIONAL DISTRICT COMMENTS and RESPONSE:

- A. Response **Exhibit C** lists the 83 parcels, an area of approximately 403.4500009 acres, that will remain in Drainage District 5.
- B. Included in a preliminary submittal to the Boundary Review Board, a copy of District Resolution No. 2024-02 was errantly included.

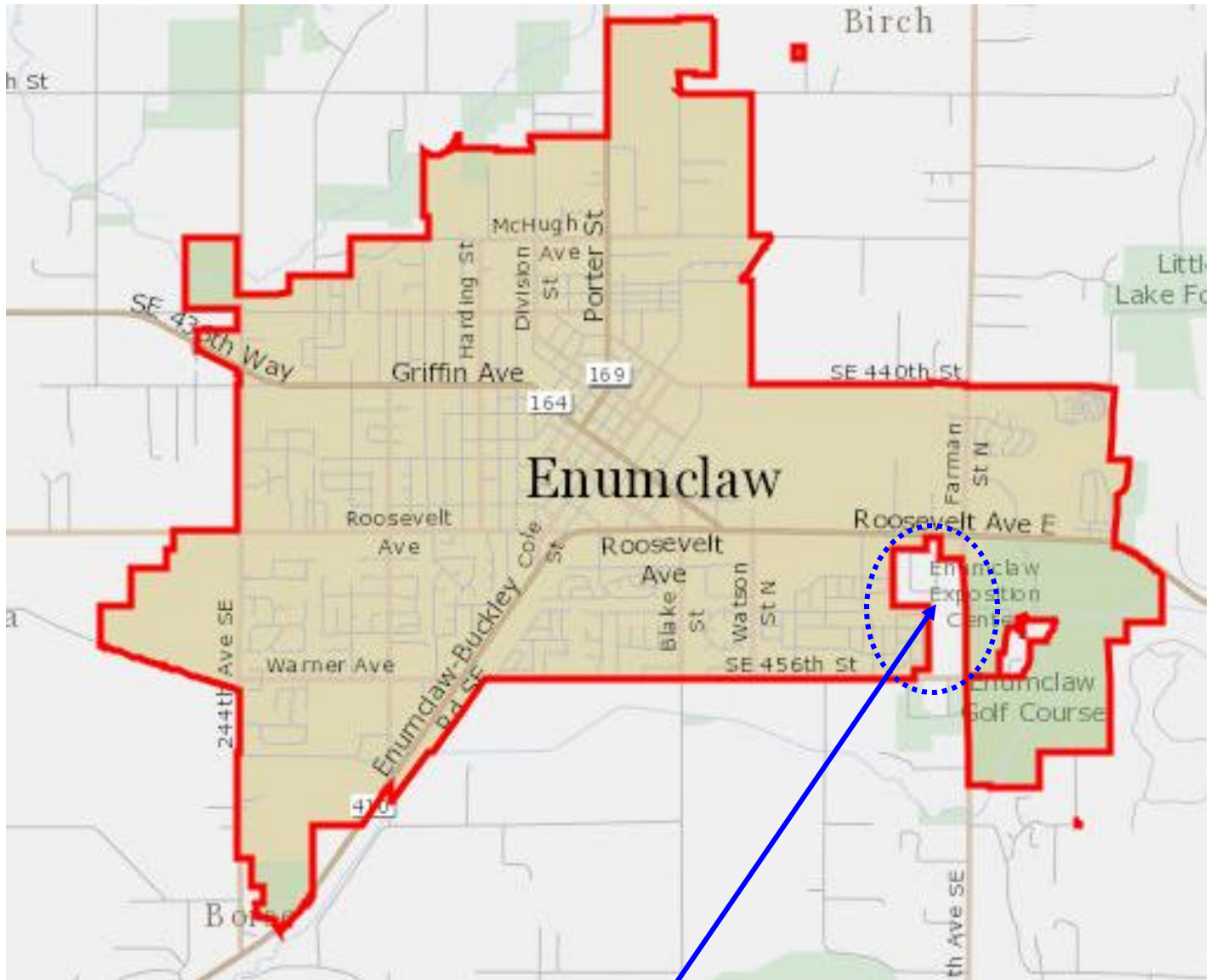

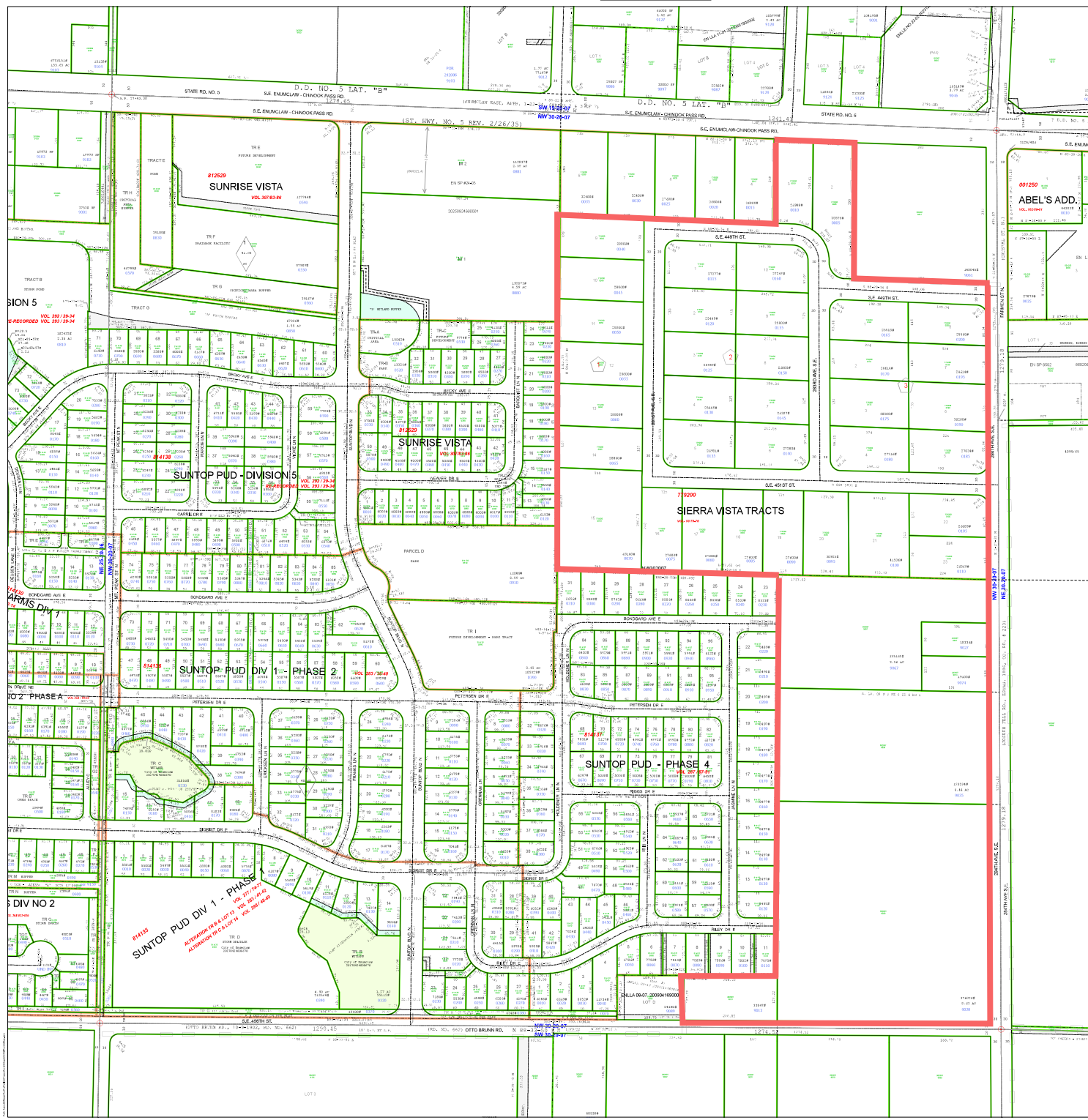
