#### ORDER OF DISMISSAL

Regional Animal Services of King County (Animal Services) served Xiaoyu Wu with a violation notice, asserting that on November 10 the Wu cat was trespassing on the complainant's property. The Wu appeal statement disputed this, asserting that the encounter happened on the community sidewalk, not on the complainant's property.

We have announced, on the record in many previous cases, that Animal Services needs to submit some sort of map (such as a screenshot from Google Earth), and that not doing so risked dismissal of a future violation notice. At our January 9 hearing, as the conversation moved to where the cat was on November 10, the lack of a map for easy identification brought this point home. A cat running at large, or being on public property, not under control sufficient

to restrain the animal from approaching a bystander or another animal, is a violation. BMC 8.04.300.B & .M; .060.W & .AA. However, these were not the violations actually cited and appealed. The cited violation was trespass, which requires proof that the cat was on another person's property. So precise location matters, and we had no map to refer to.

Animal Services' November 16, 2018, violation notice is accordingly DISMISSED.
