At today's conference, neither Animal Services nor the complaint participated. Appellant did. She noted she had received two texts from the complainants about her dogs barking. She described her ongoing attempts to soothe her dog, including obtaining some homepathic remedies.

Given the complainant's and Animal Services' lack of participation in today's call, and that there have apparently only been two barking incidents, both in the daytime, that drew a response, we DISMISS this case WITHOUT PREJUDICE.

A dismissal without prejudice is not a determination on the merits. If things flare up again, Animal Services may bring a later violation notice covering the same (and later) periods.

If for some reason we have misunderstood the situation, by **October 28, 2019,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
