Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Hearing Examiner's Office.

After hearing the witnesses' testimony and observing their demeanor, studying the exhibits admitted into evidence, and considering the parties' arguments and the relevant law, the examiner hereby makes the following findings, conclusions, and decision.

FINDINGS AND CONCLUSIONS:

- 1. Christine Fohrman was issued a Notice of Violation and Order to Comply V199009746 by Regional Animal Services of King County (RASKC) Animal Control Officer Diana Fowler for nine counts of harboring unlicensed, unaltered pets with a fine of \$250 for each animal; for a total fine of \$2,250.00.
- 2. On July 8, 2019, RASKC received a complaint that Ms. Fohrman had upwards of 15 cats on her property.
- 3. Upon arrival RASKC Officer Fowler observed seven adult cats and two eight-week old kittens.
- 4. Ms. Fohrman then told Office Fowler that she had 25-30 cats coming and going from her property.
- 5. On July 21, 2019, Sally Halela of South County Cats advised that they were willing to help Ms. Fohrman trap and alter cats to avoid civil penalties.
- 6. KCC 11.040.030 requires all dogs and cats eight weeks old or older that are harbored, kept, or maintained in King County to be licensed and registered.
- 7. On August 18, 2019, Ms. Fohrman still had nine unlicensed, unaltered cats at her residence; resulting in the above fine.
- 8. RASKC was able to prove by a preponderance of the evidence that "Ms. Fohrman" was in violation of KCC 11.040.030, therefore the notice of violation is upheld, however the associated fine shall be reduced to \$250.00.

DECISION:

1. Ms. Fohrman's appeal is denied, except that her fines are reduced to \$250.00.
