At the January 13 conference, Animal Services did not pariticipate, but that turned out not to be critical. Accordingly, we DISMISS the violation notice WITHOUT PREJUDICE. A dismissal without prejudice does not preclude Animal Services from reissuing a violation notice regarding the

same underlying event(s), if the dispute does not resolve itself. Any new violation notice would have its own separate appeal deadline and examiner process.

If for some reason we have misunderstood the situation, by **February 13, 2020,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
