Pursuant to the terms of the attached settlement agreement, we DISMISS Ms. Clark's appeal.

Bruce has been humanely euthanized; his viciousness designation and associated penalties are dismissed.

Kidd's viciousness designation remains in place. Ms. Clark agrees to comply with the terms of Animal Services' December 4, 2019, confinement order, as they pertain to Kidd. Ms. Clark shall pay a reduced \$375 civil penalty.

The settlement agreement provides that resolution of this appeal is not an admission of fault or guilt by Ms. Clark. Our dismissal is not a commentary on the merits of this case.

If for some reason we have misunderstood the situation, by **October 19, 2020**, either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
