The complainant has stated that the dog barking has lessened to a significant degree since mid-May, and that she and the neighbors do not wish to proceed a complaint at this time. Animal Services is thus withdrawing the V20010295 violation notice. That makes Ms. Sullivan's appeal of that notice moot.

Accordingly, her appeal is accordingly **DISMISSED**, the examiner's jurisdiction over the matter terminated, and the hearing scheduled for July 15, 2020, cancelled.

If for some reason we have misunderstood the situation, by **July 27, 2020**, either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
