

At our conference on September 2, the parties agreed that the situation had improved significantly, and there is not a current need for further examiner proceedings.

Accordingly, we DISMISS Animal Services July 10 violation notice without prejudice. A dismissal without prejudice is not a decision on the merits, and does not preclude Animal Services from reissuing a violation notice related to the same underlying events, if a situation deteriorates in the future.

If for some reason we have misunderstood the situation, by **October 12, 2020**, either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
