This case involves an appeal of a viciousness determination for the Appellants' dog, Gracie, after she attacked the complaint (Jeff Bowlby)'s dog Penny. At yesterday's hearing, Appellants participated, but the complaint did not. In yesterday's scenario, Animal Services could not meet its burden of proof without its witness, so we granted the appeal.

In re-reviewing our file to write this order, the complainant's no-show should not have surprised us. On September 4, he emailed us, Appellants, and Animal Services that:

Since the visit from KC Regional Animal Services officer, the Zhang household has been compliant with requirements and expectations regarding the management of their dog.

Given the \$500 fine for the citation could be severely punitive for some households, I hope you'll consider my affirmative observations when contemplating their appeal.

We somehow missed that in our preparation, but the complainant seems to have been signaling a desire not to pursue this case. And it is good to hear that Appellants have been meeting requirements and expectations.

In any event, we GRANT the Zhangs' appeal.
