FINDINGS OF FACT:

1. **Hearing**. A telephonic hearing was held November 4, 2020. Appellants Ryan Kang and Taryn Yang, appeared, as did Sergeant Eykel, Code Enforcement Officer for King County Regional Animal Services.

- 2. **Exhibits**. The exhibits listed in the minutes below were admitted without objection. Appellants requested admission of A-1 in closing argument. The document had been in Animal Service's file and there was no objection, so it was admitted.
- 3. Witnesses. Sworn testimony was received from Mr. Kang, Ms. Yang, and Ms. Maxwell.
- 4. **Notice of Violation**. King County Regional Animal Services issued a Notice of Violation and Order to Comply. Office Goldstone determined that Ryan Kang's dog, named Diesel, violated these King County animal care and control laws:

Vicious Animal, 1st Violation. KCC 11.04.230(H), \$5001

Notice and Order for Confinement. KCC 11.04.290, \$0

- 5. **Conditions.** The Notice of Violation and Order to Comply imposed these conditions:
 - Secure your animals in a fenced area suitable for the size of the animal when your animal is unattended and outside your home. Lock all passages with a padlock to prevent accidental release.
 - Restrain your animal using a leash with a collar or harness when taking it
 off your property. Your leash can extend no longer than 8' in length. A
 competent and capable person must handle the animal at all times when
 attended outside.
 - Microchip your animal and provide the microchip number to the King County Animal Licensing Office (206-296-2712) within 14 days.
 - Vaccinate your animal for rabies, if not current. ...²
- 6. Incident - September 5, 2020, about Noon. Ms. Maxwell was walking along a paved path in Snoqualmie Point Park at 37580 SE Winery Road, Snoqualmie, Washington. She noticed a man sitting on a bench with two dogs. She nodded and briefly said hello, remarking on the dogs' cute appearance. She did not stop to talk and maintained a minimum 15-foot distance, moving onto the grass and further away to social distance. After she passed the bench, one of the dogs, described as looking like a large pit bull, attacked her. She pushed him away and he came at her again, glomming onto her arm and biting through her clothing. She tried to knock him off, without success. The owner, Mr. Kang, yelled and tried to gain control of his dog by pulling the dog off her. Although wearing a long-sleeved shirt and pile jacket, her arm was bleeding and bruised. Mr. Kang apologized, gave her his information and offered to pay her medical bills. He offered transport, but Ms. Maxwell drove herself to the hospital. She suffered a laceration and puncture to her left arm. She was treated there, and received a health care bill of \$1,345.58, which her insurance covered. She testified that she still has scarring, but is no longer in pain and can use her arm.

7. **Dog Owner Testimony and Cross Examination** Mr. Kang and Ms. Yang adopted Diesel when he was four years old. He was a rescue, and they were told he was "reactive," so they put him in training. He has to be properly introduced to strangers. They believe Ms. Maxwell's brief greeting from the 15-foot distance spooked him while he was eating a dog treat, causing him to lunge at her. In the three years they have had Diesel, this is the first time he has bit anyone. They were surprised by the incident, apologized, and regret what occurred. It happened so suddenly, that though Mr. Kang had his feet on the dog's leash, Diesel instantly broke away. Mr. Kang and Ms. Yang requested that Diesel not be "labeled" a vicious dog and that the penalties be reversed. They did not object to the conditions, which they are following. Their concern is with the labeling of Diesel as a vicious dog.

CONCLUSIONS OF LAW:

- 1. **Jurisdiction**. The Examiner has jurisdiction over appeals of King County Regional Animal Services civil citations.³ In defending the appeal of these citations, it has the burden of proof.
- 2. **Vicious Animal and Order for Confinement**. A civil "vicious animal" citation may issue for:

Any animal that has exhibited vicious propensities and constitutes a danger to the safety of persons or property off the animal's premises or lawfully on the animal's premises.⁴

"Vicious" means having performed the act of, or having the propensity to do any act, endangering the safety of any person, animal or property of another, including, but not limited to, biting a human being or attacking a human being or domesticated animal without provocation.⁵

The term "vicious" is a legal term. Under King County Code, it does not mean a dog is vicious all the time, or that the dog's owners do not take good care of the dog. It simply means that the animal has exhibited certain propensities which present a danger to others.

The facts are largely undisputed. Diesel attacked Ms. Maxwell, biting and inflicting wounds requiring medical care. He was not provoked in any way. Ms. Maxwell was at least 15-feet away. The brief acknowledgement of a dog and its owner from 15-feet away does not constitute provocation for attacking and biting a person. A reasonable person would not expect to be attacked for saying hello while passing another on a walk, even if the separation distance is only a foot or two. Diesel attacked, was knocked away, and then latched onto Ms. Maxwell's arm, causing a laceration and puncture wound, despite

her thick clothing. Had Mr. Kang not pulled Diesel off, more serious injuries were likely, as Ms. Maxwell was unable to remove him. Diesel has demonstrated a propensity to endanger a person's safety, as he endangered Ms. Maxwell's safety with his attack.

Mr. Kang and Ms. Yang are complying with the conditions Animal Services imposed, regret the incident, and offered to pay for medical expenses. There is no evidence of an earlier incident, and Diesel has been in training to address his reactivity. While these are positive factors, and indicate that Mr. Kang and Ms. Yang care responsibly for Diesel, they do not change the fact that an unprovoked attack occurred.

3. Penalty. The \$500 penalty for a vicious animal citation is provided for by code. There is discretion to reduce this penalty amount if the situation is unlikely to repeat. Mr. Kang and Ms. Yang have testified they are complying with all conditions to restrain Diesel, and do not wish the incident to repeat. There is a reasonable likelihood added precautions will now be taken to ensure Diesel is under stricter control in the future, so he will not be able to attack and injure another person again. A modest reduction of \$100 is reasonable.

DECISION

The appeal is DENIED. The vicious animal citation and penalty is upheld, but with the penalty amount reduced from \$500 to \$400.
