On December 5, Animal Services posted a violation notice at the Xie property. Posting the violation notice at the front door of the owner or person with a right to control the animal is one of the three valid methods for service KCC 11.04.260.D.3. The notice listed a December 30 appeal deadline. Ms. Xie filed on January 11, stating that she missed the appeal deadline and requested another chance to appeal, given the monetary pressures.

Animal Services moved to dismiss her appeal as untimely. On February 11, we sent an electronic invitation for a February 24 hearing on Animal Services' motion. Ms. Xie accepted the electronic invite on February 11. On February 17, we emailed and mailed written notice of the hearing. We received no communication in response that the date or time were unworkable.

Animal Services' representative (Tim Anderson) promptly called in at the scheduled time. He noted that he had attempted to contact Ms. Xie about a resolution, but had not heard back. We waited 10 minutes before we dismissed Ms. Xie's appeal.

Over six hours later, Ms. Xie emailed that she was sorry she had missed the hearing and asked for reschedule. We will not be reversing our dismissal.

First, the law is clear that the examiner has no jurisdiction to entertain a late-filed appeal, and that Animal Services' December 5 decision became final and unreviewable once the December 30 deadline to appeal came and went. KCC 20.22.080.H. The examiner "shall" (mandatory) dismiss an untimely appeal. KCC 20.22.090.A.

Second, we provided a forum where Ms. Xie could offer her arguments. That just wound up wasting everyone's time when she did not participate. We will not be rescheduling. Ms. Xie may want to reach out to Animal Services about payment resolution, but the Examiner's role is at an end.

Ms. Xie's appeal is DISMISSED on both jurisdictional and failure-to-appear grounds.
