#### **SUMMARY ORDER**

Mahnaz Akbari testified that at several points, as she and her husband walked their dog down the public sidewalk in the vicinity of the Carruthers' house, the Carruthers' dog, Leni, came off the property, barked at them, and followed after them. In one of those incidents, Ms. Akbari twisted her wrist.

On November 24, as Ms. Akbari walked her dog by the Carruthers house, Leni was loose again. Ms. Akbari saw Ms. Carruthers at their door, talking to who Mr. Carruthers would later explain was the nanny. Ms. Akbari approached Ms. Carruthers and asked her to contain Leni. Ms.

Carruthers brushed her off. Ms. Akbari then moved back across the street and videoed Leni out and on Ms. Akbari's side of the street, while Mr. Carruthers and the nanny conversed in the Carruthers' doorway across the street. Ex. D3.<sup>1</sup> Ms. Akbari filed a complaint with Animal Services later that day. Ex. D10.

On Christmas day, Leni was out as Ms. Akbari walked by again. Ms. Akbari would later submit video of Leni loose, barking, and then following her. Ex. D4. Ms. Akbari called in a second complaint later that evening, and followed up with an email a few days later. Exs. D11, D2.

Animal Services responded by contacting the Carruthers on December 30. The officer spoke with Mr. Carruthers, who denied Leni had been out on Christmas and requested public records. Ex. D5 at 002, n.3.

Animal Services served a violation notice on January 3, related to the Christmas Day running at large. Ex. D8. Having received Ms. Akbari's email via the Public Records Act disclosure, Ms. Carruthers emailed Ms. Akbari on January 29, and then filed an appeal on February 1, disputing that Leni was running at large. Exs. D15 & D13.

We went to hearing on March 18. Having reviewed the video, Mr. Carruthers agreed it was Leni running at large, apologized for their initial reaction, and provided some context. He agreed they had not done enough to contain Leni, and he explained the steps they have since taken (including purchasing a shock collar and educating their kids about not letting Leni out). Ms. Akbari accepted the apology, and noted that in the future, if Leni gets out again, she will reapproach them directly, instead of calling Animal Services.

There is not much to discuss. Mr. Carruthers' acceptance of responsibility and apology are certainly well-taken, both by Ms. Akbari and by us. Obviously the Carruthers will need to continue their recent efforts to contain Leni, but they seem to be on the road to doing that. And they have re-opened the door for Ms. Akbari to again try contacting them directly, if Leni gets out in the future.

In sum, we DENY the Carruthers' appeal.
