At yesterday's hearing, Ms. Wilkes promptly appeared, but neither Animal Services nor the complainant participated. After 10 minutes, we announced we would grant the appeal, dismissing the notice and order.

Within the hour, Animal Services' representative emailed to explain that an employee had been injured that morning, and she had to drive the employee to get treatment. She asked to reschedule.

That is certainly a valid excuse. And we have had at least one case where the Animal Services representative did not appear at hearing but the complainant and appellant did. There, we swore in the complainant and appellant, got their respective testimonies, and decided the case on the merits.

However, yesterday the complainant did not appear either. While we have sustained minor nuisance violations without a complainant present (such as where a complainant submits a photo showing appellant's dog trespassing, then does not appear at hearing), we have yet to sustain a vicious dog violation (a designation that has lifetime implications for the owner and the dog) absent a complainant offering testimony under oath and subject to cross examination. So, even if Animal Services had appeared at yesterday's hearing, we would have overturned the violation anyway.

We GRANT Ms. Wilkes' appeal.
