At the October 28 pre-hearing conference, Animal Services noted that the complainant had advised that Appellant had significantly improved the noise situation. Animal Services is thus dismissing without prejudice its June 25 violation notices. There being no more violation notices to challenge, Appellant's appeal of those notices is moot. We thus dismiss the appeal.
