Animal Services emailed that, as the Morrows were apparently being more successful at keeping their cats from trespassing, it is dismissing violation V21012491, without prejudice, and encouraging the current compliance to continue moving forward.

A dismissal without prejudice does not preclude Animal Services from reissuing a violation notice regarding the same underlying event, if the dispute does not resolve itself. Any new violation notice would have its own separate appeal deadline and examiner process.

The appeal is accordingly DISMISSED, the examiner's jurisdiction over the matter terminated, and today's pre-hearing conference cancelled.

If for some reason we have misunderstood the situation, by **November 15, 2021,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
