At our abbreviated October 12 hearing, the Tislenoks explained that they were down to three dogs at the subject property. Animal Services noted that the Tislenoks had (as of October 12) reduced the noise levels to acceptable levels. We stayed the case and noted that we would check back in with the parties at an April 14 conference to confirm that the noise had not ramped up, and, if noise levels remained acceptable, would dismiss the pending violation (here, V20011397).

At yesterday's conference, Ms. Tislenok participated, but neither Animal Services nor the neighbors did. We take that is a pretty long indication that there is no longer an active dispute.

Accordingly we DISMISS WITHOUT PREJUDICE violation V20011397.

If for some reason we have misunderstood the situation, by **May 16, 2022,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
