At the June 14 conference, the complainant explained that the Reeds had moved the roosters further away and taken other steps to make the current situation tolerable.

In light of that improvement we dismiss, without prejudice, violation V21012632. A dismissal without prejudice is not a ruling on the merits, and it does not prevent Animal Services from reissuing a violation if the situation deteriorates.

If for some reason we have misunderstood the situation, by **July 18, 2022**, either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
