

Animal Services advised us that the complainant reports that the Appellants have been able to successfully reduce the barking. As such, Animal Services requests that we dismiss without prejudice the pending violation notice. A dismissal without prejudice does not preclude Animal Services from reissuing a violation notice regarding the same underlying event(s) if a problem reemerges. But it removes a case from everyone's workload when there is no current dispute. Any future violation notice would have its own separate appeal deadline and examiner process.

As there is no longer any active violation notice to challenge, we DISMISS the appeal.

If for some reason we have misunderstood the situation, by **September 26, 2022,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
