As Appellant has been able to successfully remedy the situation, Animal Services is dismissing, without prejudice, the pending violation notice. Such a dismissal does not preclude Animal Services from reissuing a violation notice for the same underlying event(s) if a problem re-emerges. But it removes a case from everyone's workload when there is no current dispute. Any future violation notice would have its own separate appeal deadline and examiner process.

As there is no longer any active violation notice to challenge, we DISMISS the appeal.

If for some reason we have misunderstood the situation, by **November 24, 2022**, either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
