Regional Animal Services of King County has notified us that the complainant has advised that the situation has greatly improved, with them no longer being awakened by the rooster crowing. In light of this, Animal Services is dismissing its violations without prejudice.

A dismissal without prejudice is not a decision on the merits and does not bar Animal Services from later re-issuing a violation notice. But it does mean there is currently no violation for Mr. Harvey to challenge. His appeal is accordingly DISMISSED, the examiner's jurisdiction over the matter terminated, and the hearing scheduled for January 10, 2023, cancelled.

If for some reason we have misunderstood the situation, by **January 27, 2023,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
