On August 29, we wrote that because the parties had resolved the *noise* dispute, we were dismissing violation V22013866 without prejudice. However, because the original case was old, we had forgotten that in addition to citing Scout, Brody, and Cy for barking (which has now been resolved), as of the date of the December 2022 violation notice, neither Scout, Brody, and Cy were licensed, and Animal Services had cited Scout, Brody, and Cy for being unlicensed. Ms. Sprute did *not* dispute the licensing violations in her January 2023 appeal.

Yesterday my office received the following from Sgt. Eykel:

When removing the charges for the barking violations for V23-013866 I saw there are also licensing violations. I looked and there are no licenses for animals at the Sprute residence. I have removed the \$150 in fines for excessive barking, but the \$375 for unlicensed animals remains and will be referred for collections as this violation is from 2022.

Thus apparently Scout, Brody, and Cy are *still* not licensed. Thus we amend our August 29 dismissal order as follows:

The three barking violations from V22013866 are dismissed without prejudice.

The three licensing violations and \$375 in penalties from V22013866 remain.

Our September 6, 2023, conference is cancelled.

If for some reason we have misunderstood the situation, by **October 2, 2023,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
